A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the cultural and 2 historic heritage of Native Hawaiians is among the State's 3 important assets and the rapid social and economic developments 4 of contemporary society threatens to destroy the remaining 5 vestiges of Native Hawaiian heritage. Recently, there have been 6 a number of incidents of property holding cultural or historical significance to Native Hawaiians being damaged or vandalized. 7 8 For example, in May 2017, a canoe club in east Oahu reported 9 that the ropes rigging the club's canoes had been slashed in two 10 separate incidents within the same week, and three historic 11 doors of Iolani Palace were vandalized. In October 2017, the 12 Prince Kuhio statue in Waikiki was spray painted orange in an 13 act of vandalism.

14 The legislature further finds that these acts involved 15 properties that hold cultural or historical significance to 16 Native Hawaiians. While these acts may be charged under 17 existing criminal statutes, the damage to these properties under

1 the circumstance has outraged the sensibilities of persons who 2 observed or discovered the perpetrator's actions. Thus, 3 additional criminal penalties that are specific to damage to property holding cultural or historical significance to Native 4 5 Hawaiians are necessary to preserve and provide stronger 6 deterrents against damage to Native Hawaiian heritage vestiges. 7 The purpose of this Act is to amend the offenses of 8 criminal property damage in the first, second, and third degrees 9 to include damage to property holding cultural or historical 10 significance to Native Hawaiians. SECTION 2. Section 708-800, Hawaii Revised Statutes, is 11 12 amended by adding a new definition to be appropriately inserted 13 and to read as follows: 14 "Property holding cultural or historical significance to 15 Native Hawaiians" means property that perpetuates Hawaiian 16 traditional knowledge, strengthens cultural or spiritual 17 connections among Native Hawaiians, or has demonstrable benefits 18 to the Native Hawaiian community." 19 SECTION 3. Section 708-820, Hawaii Revised Statutes, is 20 amended by amending subsection (1) to read as follows:

8	SECTION 6. This Act does not affect rights and duties that
9	matured, penalties that were incurred, and proceedings that were
10	begun before its effective date.
11	SECTION 7. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 8. This Act shall take effect upon its approval.
