BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 312-3.6, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) There is established in the state treasury a
4	libraries special fund into which shall be deposited all moneys

8	SECTION 2. Section 523A-19, Hawaii Revised Statutes, is
9	amended by amending subsection (c) to read as follows:
10	"(c) Beginning on July 1, 2014, any claim made under this
11	part for funds in the unclaimed property trust fund shall be
12	void if the claim is:
13	(1) For funds totaling less than $[\$100;]$ $\$250;$ and
14	(2) Filed more than ten years after the date that the full
15	amount of the claim was deposited into the unclaimed
16	property trust fund;

1	provided that for funds totaling less than $[\$100]$ $\$250$ that were
2	deposited into the unclaimed property trust fund on or prior to
3	June 30, 2014, the ten-year time limitation on claiming the
4	funds shall commence on July 1, 2014. Unclaimed funds <u>of \$10 or</u>
5	less subject to this subsection, upon the expiration of the ten-
6	year time limitation, shall escheat to the State and be
7	transferred to the libraries special fund. Unclaimed funds of
8	more than \$10 but less than \$250 subject to this subsection,
9	upon the expiration of the ten-year time limitation, shall
10	escheat to the State and be transferred to the general fund."
11	SECTION 3. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 4. This Act shall take effect on July 1, 2050.

Unclaimed Property; Public Library System; Libraries Special Fund

Description:

Specifies that unclaimed funds of \$10 or less in the Unclaimed Property Trust Fund, upon the expiration of the ten-year time limitation on claiming the funds, shall be transferred to the Libraries Special Fund. Increases the threshold for claims for funds from the Unclaimed Property Fund that are subject to the ten-year expiration period, from \$100 to \$250. (SB2921 HD1)
