A BILL FOR AN ACT

RELATING TO SUICIDE PREVENTION TRAINING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In Hawaii, on average, one person dies by
- 2 suicide every two days. Suicide is the fourth leading cause of
- 3 death for children between the ages of ten and fourteen, and is
- 4 the leading cause of death for young people between the ages of
- 5 fifteen and twenty-four. In Hawaii, suicide accounts for
- 6 twenty-five per cent of all fatal injuries.
- 7 Suicide rates vary by area, with neighbor island and rural
- 8 communities seeing higher rates than urban areas. For the
- 9 period from 2013 to 2015, the statewide suicide rate was 12.9
- 10 deaths for every one hundred thousand individuals. For the same
- 11 time period, for every one hundred thousand people, the counties
- 12 of Hawaii, Maui, and Kauai had 20.4, 15.9, and 14.6 deaths,
- 13 respectively. The City and County of Honolulu's suicide rate,
- 14 at 10.3 deaths for every one hundred thousand people, was
- 15 slightly lower than the state average.
- 16 According to the state department of health, the percentage
- 17 of teenagers in Hawaii who plan to commit suicide and the

- 1 percentage of teenagers who attempt suicide are among the
- 2 highest in the nation. For the period from 2005 to 2013, the
- 3 percentage of high school-aged children with suicide ideation in
- 4 Hawaii ranged from sixteen to twenty per cent. For the same
- 5 time period, the percentage of high school-aged children treated
- 6 for a suicide attempt never dipped below three per cent.
- 7 Suicide attempts, like suicide deaths, have harmful,
- 8 lasting, and profound impacts on families and communities. For
- 9 every person that dies by suicide, more than thirty others
- 10 attempt suicide. Therefore, it is important to monitor
- 11 hospitals and emergency departments to identify individuals in
- 12 need of immediate intervention.
- 13 The stigma of seeking mental health counseling places
- 14 formidable barriers to providing care and support to individuals
- 15 in crisis. States across the nation have sought to address this
- 16 issue by passing legislation mandating that teachers complete
- 17 in-service training in youth suicide awareness and prevention.
- 18 In 2007, Tennessee passed the Jason Flatt Act, which required
- 19 all educators in the state to complete two hours of youth
- 20 suicide awareness and prevention training every year to be

- 1 licensed to teach. Nineteen states have passed variations of
- 2 the Jason Flatt Act.
- 3 The legislature finds that there is a need to increase the
- 4 number of individuals in educational institutions, such as
- 5 teachers, principals, and school counselors, who are trained to
- 6 identify youth at risk of suicide and refer those children to
- 7 appropriate services, counseling, and intervention.
- 8 The purpose of this Act is to require all teachers,
- 9 principals, and school counselors to complete two hours of
- 10 suicide prevention and education training each year.
- 11 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 12 amended by adding a new section to be appropriately designated
- 13 and to read as follows:
- 14 "§302A- Suicide prevention; in-service training. The
- 15 department shall require that in-service training include at
- 16 least two hours of suicide prevention education for all
- 17 teachers, principals, and school counselors each school year.
- 18 This education may be accomplished through the provision and
- 19 completion of suicide prevention materials approved by the
- 20 department."
- 21 SECTION 3. New statutory material is underscored.

SECTION 4. This Act shall take effect upon its approval.
