A BILL FOR AN ACT

RELATING TO HIGHER EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaiian is an
- 2 official language of the State and the legislature has a unique
- 3 responsibility to promote its use and study. In fulfillment of
- 4 that responsibility, the 1997 legislature mandated the
- 5 establishment of a Hawaiian language college at the University
- 6 of Hawai'i at Hilo with a mission to operate a Hawaiian language
- 7 medium laboratory school, a Hawaiian medium teacher education
- 8 program, a Hawaiian language materials and resource center, and
- 9 a language revitalization focused graduate program and perform
- 10 outreach to other indigenous people.
- 11 The legislature further finds that the Hawaiian language
- 12 college established in accordance with the legislative mandate
- 13 was named Ka Haka 'Ula O Ke'elikōlani in honor of Princess Ruth
- 14 Ke'elikōlani, who was well-known for her commitment to the
- 15 maintenance and normalized use of the Hawaiian language and
- 16 culture in government and community functions. In 2014, the
- 17 State completed the first phase of a building plan for the

- 1 Hawaiian language college that housed classrooms, but other
- 2 needs relative to the Hawaiian language curriculum and resource
- 3 center, demonstration classrooms for its teacher education
- 4 program, and facilities for outreach to other indigenous peoples
- 5 were placed on hold for the future. Growth in enrollment,
- 6 programming, and international prominence of the work of the
- 7 Hawaiian language college are such that it is appropriate at
- 8 this time to fund facilities earlier placed on hold. There is
- 9 especially a need to include facilities related to the teacher
- 10 preparation, curriculum development, and outreach functions of
- 11 the Hawaiian language college.
- 12 The purpose of this Act is to require and appropriate funds
- 13 to the University of Hawai'i at Hilo to, in collaboration with
- 14 faculty, staff, and other partners, update and strengthen the
- 15 plans for full development of Ka Haka 'Ula O Ke'elikōlani.
- 16 SECTION 2. (a) The University of Hawai'i at Hilo, in
- 17 collaboration with Ka Haka 'Ula O Ke'elikolani faculty, staff,
- 18 and other partners, shall develop a plan for full development of
- 19 Ka Haka 'Ula O Ke'elikōlani.
- 20 (b) The University of Hawai'i at Hilo shall submit its
- 21 plan, including any proposed legislation, to the legislature no

- 1 later than twenty days prior to the convening of the regular
- 2 session of 2019.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2018-2019 to
- 6 the University of Hawai'i at Hilo to update and strengthen the
- 7 plans for full development of Ka Haka 'Ula O Ke'elikōlani.
- 8 The sum appropriated shall be expended by the University of
- 9 Hawai'i for the purposes of this Act.
- 10 SECTION 4. This Act shall take effect on July 1, 2018.
