#### A BILL FOR AN ACT

RELATING TO AQUACULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that aquaculture is one 2 of the fastest growing animal food production sectors and 3 accounts for nearly half of the supply of fish for consumption 4 around the world. As such, aquaculture is of fundamental 5 importance for providing opportunities for revenue generation, 6 employment, and food security. The legislature further finds 7 that Hawaii is uniquely suited to benefit from aquaculture, but 8 that lack of support for the importation of new species or 9 genetic lines for land-based systems causes food-focused 10 aquaculture in the State to fall short of its potential.

11 The legislature additionally finds that the plant 12 quarantine branch of the department of agriculture currently 13 administers that importation process for aquaculture livestock, 14 and that the procedures used by the plant quarantine branch 15 cause unnecessary and avoidable delays in aquatic livestock 16 species development in Hawaii. The legislature also finds that 17 the division of animal industry of the department of agriculture

3	(1)	The division effectively administers or facilitates	
4		the movement of cattle, swine, poultry, sheep, and	
5		goats for Hawaii;	
6	(2)	Veterinarians working for the division implement the	
7		United States Department of Agriculture's animal	
8		disease traceability framework, which is a system for	
9		moving livestock interstate that involves pre-arrival	
10		disease-free verification, and point-of-entry and	
11		post-arrival inspections to ensure compliance with	
12		program requirements;	
13	(3)	The division works closely with the United States	
14		Department of Agriculture and can access a global	
15		network of government and industry partners for	
16		additional support on aquatic livestock policy and	
17		development issues; and	
18	(4)	Veterinarians working for the division possess	
19		training and expertise in animal health and behavior,	
20		production systems, and disease identification and	
21		stay current on animal health and development

7	SECT	ION 2. Section 150A-6.2, Hawaii Revised Statutes, is	
8	amended to read as follows:		
9	"§15(	<b>DA-6.2 Animal import.</b> (a) The board shall maintain:	
10	(1)	A list of conditionally approved animals that require	
11		a permit for import into the State;	
12	(2)	A list of restricted animals that require a permit for	
13		both import into the State and possession; and	
14	(3)	A list of animals that are prohibited entry into the	
15		State.	
16	(b)	The board shall adopt rules, pursuant to chapter 91,	
17	to establish an advisory committee of no fewer than three		
18	members with applicable expertise in vertebrate biology to		
19	identify whether an animal is a prohibited hybrid animal when		
20	the depart	ment suspects that the lineage of the animal is not as	
21	stated by	the owner or on other official documents.

1 (c) Animals on the lists of conditionally approved and 2 restricted animals shall be imported only by permit. Any animal 3 that is not on the lists of conditionally approved, restricted, 4 or prohibited animals shall be prohibited until the board's 5 review and determination for placement on one of these lists; 6 provided that the department may issue a special permit on a 7 case-by-case basis for the importation and possession of an 8 animal that is not on the lists of prohibited, restricted, or 9 conditionally approved animals, for the purpose of remediating 10 medical emergencies or agricultural or ecological disasters, or 11 conducting medical or scientific research in a manner that the 12 animal will not be detrimental to agriculture, the environment, 13 or humans, if the importer of the animal can meet permit requirements as determined by the board; and provided further 14 15 that the department may issue a short-term special permit on a 16 case-by-case basis not to exceed ninety days for the importation 17 and possession of an animal that is not on the lists of prohibited, restricted, or conditionally approved animals for 18 19 the purpose of filming, performance, or exhibition, if the 20 importer of the animal can meet permit and bonding requirements 21 as determined by the board.



1 (d) Inspection, quarantine, and approval of aquaculture 2 livestock animals shall be performed and administered by the 3 division of animal industry." 4 SECTION 3. All rights, powers, functions, and duties of 5 the plant quarantine branch within the division of plant 6 industry of the department of agriculture relating to the 7 inspection, guarantine, and approval of aquaculture livestock 8 animals are transferred to the division of animal industry of 9 the department of agriculture. 10 All employees who occupy civil service positions and whose functions are transferred to the division of animal industry by 11 12 this Act shall retain their civil service status, whether 13 permanent or temporary. Employees shall be transferred without 14 loss of salary, seniority (except as prescribed by applicable 15 collective bargaining agreements), retention points, prior 16 service credit, any vacation and sick leave credits previously 17 earned, and other rights, benefits, and privileges, in accordance with state personnel laws and this Act; provided that 18 19 the employees possess the minimum qualifications and public 20 employment requirements for the class or position to which 21 transferred or appointed, as applicable; provided further that



subsequent changes in status may be made pursuant to applicable
civil service and compensation laws.

3 Any employee who, prior to this Act, is exempt from civil 4 service and is transferred as a consequence of this Act may 5 retain the employee's exempt status, but shall not be appointed 6 to a civil service position as a consequence of this Act. An 7 exempt employee who is transferred by this Act shall not suffer 8 any loss of prior service credit, vacation or sick leave credits 9 previously earned, or other employee benefits or privileges as a 10 consequence of this Act; provided that the employees possess 11 legal and public employment requirements for the position to 12 which transferred or appointed, as applicable; provided further 13 that subsequent changes in status may be made pursuant to 14 applicable employment and compensation laws. The chairperson of 15 the board of agriculture may prescribe the duties and 16 qualifications of these employees and fix their salaries without 17 regard to chapter 76, Hawaii Revised Statutes.

SECTION 4. All rules, policies, procedures, guidelines, and other material adopted or developed by the plant quarantine branch within the division of plant industry of the department of agriculture relating to the inspection, quarantine, and

approval of aquaculture livestock animals shall remain in full 1 2 force and effect until amended or repealed by the division of 3 animal industry pursuant to chapter 91, Hawaii Revised Statutes. In the interim, every reference to the plant quarantine branch 4 5 or the branch chief in those rules, policies, procedures, 6 quidelines, and other material is amended to refer to the division of animal industry of the department of agriculture or 7 administrator, as appropriate. 8

9 SECTION 5. All appropriations, records, equipment, 10 machines, files, supplies, contracts, books, papers, documents, maps, and other personal property heretofore made, used, 11 12 acquired, or held by the plant quarantine branch within the 13 division of plant industry of the department of agriculture 14 relating to the functions transferred to the division of animal industry of the department of agriculture shall be transferred 15 with the functions to which they relate. 16

17 SECTION 6. New statutory material is underscored.

18 SECTION 7. This Act shall take effect upon its approval.
