BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 339D-10, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "[+]\$339D-10[+] Electronic device recycling fund. (a)
- 4 There is established in the state treasury the electronic device
- 5 recycling fund into which shall be deposited all fees, payments,
- 6 and penalties collected by the department pursuant to this
- 7 chapter.
- 8 (b) The electronic device recycling fund shall be
- 9 administered by the department of health. Moneys in the fund
- 10 shall be expended by the director [solely] for the purpose of
- implementing [and enforcing] this chapter[-], including:
- 12 (1) Reimbursement for collection services associated with
- the handling and collecting of electronic devices for
