6	identified pursuant to this part, that:	
7	(1)	Are capable of producing sustained high agricultural
8		yields when treated and managed according to accepted
9		farming methods and technology;
10	(2)	Contribute to the State's economic base and produce
11		agricultural commodities for export or local
12		consumption; or
13	(3)	Are needed to promote the expansion of agricultural
14		activities and income for the future, even if
15		currently not in production.

"Landowner" means any private landowner, any owner of

public lands as defined under section 171-2, and any tenant of

public lands."
