# A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the modern economy 2 requires colleges to react quickly to meet the changing 3 technical workforce demands of the public and private sectors, 4 to fill emerging job opportunities and upgrade the skills of 5 workers to meet the changing requirements of their positions as 6 technology advances. Examples include entry level informational 7 technology positions, security service positions, health and 8 home care positions, and, particularly since the closure of the 9 last sugar plantation, agricultural workers. To be responsive 10 to workforce needs, the training must be developed and delivered 11 rapidly, often in a format other than a formal degree program.

12 The purpose of this Act is to make explicit the 13 responsibility of the University of Hawaii community colleges to 14 provide short-term and rapid response occupational training and 15 certification programs designed to qualify individuals to fill 16 new and hard-to-fill positions of the State, counties, and 17 private sector that require technical training.

The 4 report shall include: 5 (1)The organizational structure of the occupational 6 training and certification programs; 7 (2) The efficacy of the method used to identify the new 8 and hard-to-find classes of positons that are suitable 9 for the programs; 10 (3) A cost-benefit analysis of the programs; and 11 (4) Whether the programs should be expanded, modified, or terminated. 12 13 SECTION 4. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so much 15 thereof as may be necessary for fiscal year 2017-2018 and the 16 same sum or so much thereof as may be necessary for fiscal year 17 2018-2019 for occupational training and certification programs 18 designed to rapidly qualify persons to fill new and hard-to-fill 19 classes of non-professional positions in the State, counties, 20 and private sector that require technical skills.
