The committee shall be composed of thirteen members 6 7 [appointed by the governor, as provided in section 26-34, except as otherwise] as provided in this section. Of the thirteen 8 members: 10 Three members shall be representatives of the (1)11 aerospace industry[-] and appointed by the governor, 12 as provided in section 26-34. One member shall be 13 appointed from a list of nominees submitted by the 14 president of the senate, and one member shall be 15 appointed from a list of nominees submitted by the 16 speaker of the house of representatives;
