RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to collective bargaining  
4 statewide (BUF 102) the following sums or so much thereof as may  
5 be necessary to fund for fiscal biennium 2017-2019 all  
6 collective bargaining cost items in the agreement negotiated  
7 with the exclusive representative of collective bargaining unit  
8 (9):

15 SECTION 14. Funds appropriated or authorized by this Act  
16 that are not expended or encumbered by June 30, 2018, and June  
17 30, 2019, of the respective fiscal years, shall lapse as of  
18 those dates.

19 SECTION 15. This Act shall take effect on July 1, 2017.
