## A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS RELATED TO THE TRANSITION OF MAUI REGION HOSPITALS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to make an
- 2 appropriation for collective bargaining cost items to facilitate
- 3 the transition of affected Maui region hospital employees to
- 4 employment with Maui Health System, a Kaiser Foundation
- 5 Hospitals LLC. The transition of the operations of the Maui
- 6 region hospitals was approved by the legislature pursuant to Act
- 7 103, Session Laws of Hawaii 2015, and a subsequent transfer
- 8 agreement approved by the governor, Maui region board of
- 9 directors, Hawaii health systems corporation, and Kaiser
- 10 Foundation Hospitals LLC on January 14, 2016.
- 11 Pursuant to section 89-10, Hawaii Revised Statutes,
- 12 requests for appropriations for collective bargaining cost items
- 13 negotiated between the employer and exclusive representatives
- 14 are to be presented to the legislature for their consideration.
- 15 This measure is requesting a general fund appropriation to make
- 16 payments to affected Maui region hospital employees pursuant to



- 1 supplemental agreements negotiated between the employer and
- 2 exclusive representatives after the transfer agreement was
- 3 approved.
- 4 The appropriation for these respective supplemental
- 5 agreements will ensure that operations will not be negatively
- 6 impacted and the health care of the community will not be
- 7 compromised.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii, the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year for
- 11 collective bargaining cost items to facilitate the transition of
- 12 affected Maui region hospital employees from employment with the
- 13 Maui region hospitals to Maui Health System, a Kaiser Foundation
- 14 Hospitals LLC.
- The sum appropriated shall be expended by the department of
- 16 budget and finance for the purposes of this Act.
- 17 SECTION 3. The appropriations made under section 2 shall
- 18 not lapse at the end of the fiscal year for which the
- 19 appropriations are made; provided that all moneys from the
- 20 appropriation unencumbered as of June 30, 2018, shall lapse as
- 21 of that date.

1 SECTION 4. This Act shall take effect on July 1, 2050.
