A BILL FOR AN ACT

RELATING TO SERVICES PERFORMED BY CIVIL SERVICE EMPLOYEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in 1997, the Hawaii
- 2 supreme court ruled in Konno v. Hawaii County that Hawaii county
- 3 violated civil service laws and merit principles when it hired
- 4 private contractors to perform landfill operations work. The
- 5 court ruled that state civil service laws allowed only civil
- 6 service employees to perform work historically and customarily
- 7 done by civil service employees.
- 8 In response to Konno, Act 90, Session Laws of Hawaii 2001,
- 9 was enacted in 2001. Act 90, part II, allowed the State of
- 10 Hawaii to contract for services historically and customarily
- 11 performed by civil service employees if equivalent or better
- 12 services could be provided at lower cost. However, Act 90, part
- 13 II, was repealed on June 30, 2007.
- 14 After Act 90 was repealed, the United Public Workers filed
- 15 class grievances as well as lawsuits in circuit court arguing
- 16 that the State of Hawaii and the counties should cease the
- 17 practice of contracting for services historically and



- 1 customarily performed by civil service employees. Over time,
- 2 the counties reached settlements with the United Public Workers,
- 3 leaving only the claims against the State of Hawaii.
- 4 Through court-ordered mediation, an agreement was reached
- 5 between the United Public Workers and the State of Hawaii
- 6 executive branch relating to services historically and
- 7 customarily performed by civil service employees as it relates
- 8 to the United Public Workers. This agreement reflected the
- 9 State's commitment to comply with the Hawaii supreme court's
- 10 ruling in Konno, while concurrently recognizing the State's duty
- 11 to provide services to the public.
- 12 Without a sufficient number of civil service positions and
- 13 employees to perform services historically and customarily
- 14 performed by United Public Workers-type employees, state
- 15 agencies have had to resort to contracting for these services.
- 16 In order to address this situation and enable state agencies to
- 17 comply with the Konno ruling, it is estimated that the State
- 18 will need an additional 599 permanent positions and
- 19 approximately \$105,091,764 (for positions and associated
- 20 equipment) in general and non-general funds in order to provide
