## SENATE CONCURRENT RESOLUTION

REQUESTING THE STATE AUDITOR TO CONDUCT A PERFORMANCE AUDIT OF THE DEPARTMENT OF AGRICULTURE'S PROCEDURES RELATING TO AQUACULTURE IMPORTATION PERMIT APPLICATIONS.

WHEREAS, the Department of Agriculture is charged with 1 2 enforcing rules relating to the importation of animals that may be detrimental to the agricultural, horticultural, and 3 aquacultural industries, natural resources, and environment of 4 Hawaii; and 5 6 WHEREAS, section 4-71-3, Hawaii Administrative Rules, 7 establishes that "[a]ll importation of animals shall be by . 8 permit"; and 9 10 WHEREAS, section 4-71-4, Hawaii Administrative Rules, 11 establishes that the Board of Agriculture shall approve or 12 disapprove permit applications for the importation of animals 13 14 into the State; and 15 WHEREAS, section 4-71-4.1, Hawaii Administrative Rules, 16 provides for the maximum time periods for permit approvals, 17 disapprovals, extensions, or automatic approvals for the 18 importation of animals into the State; and 19 20 WHEREAS, section 4-71-4.1(c), Hawaii Administrative Rules, 21 22 states that notwithstanding certain exceptions, "an application request for the issuance of a permit shall be given automatic 23 approval if action is not taken by the department [of 24 agriculture] within the established maximum period of time" and 25 that "[a] fter the expiration of the maximum time period is 26 27 brought to the attention of the department, the department shall have a reasonable amount of time to issue the permit"; and 28 29 WHEREAS, local farmers and others are ready and able to 30 bring additional aquaculture to the State that can assist the 31

State in achieving local food production and sustainability 1 2 qoals; and 3 4 WHEREAS, there are reports of several incidents in which those seeking to import aquaculture to the State have not 5 received permits from the Department of Agriculture within the 6 maximum time periods or within a reasonable amount of time after 7 the expiration of the maximum time periods established in the 8 Hawaii Administrative Rules; now, therefore, 9 10 BE IT RESOLVED by the Senate of the Twenty-ninth 11 Legislature of the State of Hawaii, Regular Session of 2018, the 12 House of Representatives concurring, that the State Auditor is 13 14 requested to conduct a performance audit of the Department of Agriculture's procedures for permit applications relating to the 15 importation of aquaculture to determine the causes of any 16 failure to adhere to applicable Hawaii Administrative Rules; and 17 18 19 BE IT FURTHER RESOLVED that the State Auditor is requested 20 to submit a report of findings and recommendations, including any proposed legislation, to the Legislature no later than 21 twenty days prior to the convening of the Regular Session of 22 2019; and 23 24 25 BE IT FURTHER RESOLVED that the Department of Agriculture is requested to submit a report to the Legislature, no later 26 than twenty days prior to the convening of the Regular Session 27. of 2019, detailing all permit applications relating to the 28 importation of aquaculture received since 2011, including the 29 date of the application, date of approval or disapproval, date 30 of issuance of the permit if applicable, and an explanation 31 describing the reasons for the failure to issue a permit within 32 33 the maximum time limits or within a reasonable time thereafter, pursuant to the Hawaii Administrative Rules; and 34 35 36 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the State Auditor and 37
