SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO ENSURE THAT ALL PUBLIC
SCHOOL STUDENTS, INCLUDING PUBLIC CHARTER SCHOOL STUDENTS,
HAVE EQUAL ACCESS TO APPROPRIATE EDUCATIONAL FACILITIES AND
FOOD SERVICE.

1 WHEREAS, all charter schools in Hawai'i are chartered by the
2 State Public Charter School Commission under the oversight of
3 the Board of Education and subject to the operating parameters
4 of the Department of Education for facilities and food services;
5 and
6

7 WHEREAS, there are two types of charter schools in Hawai'i:
8 start-up charter schools with no operating facilities and
9 charter schools that were converted from Department of Education
10 schools with facilities; and
11

12 WHEREAS, there are thirty-seven charter schools in Hawai'i,
13 of which over half are committed to Hawaiian epistemology; are
14 community designed and controlled; and reflect, respect, and
15 embrace 'ōlelo Hawai'i, 'ike Hawai'i, and Hawaiian cultural
16 values, philosophies, and practices; and
17

18 WHEREAS, there are nearly twelve thousand charter school
19 students in Hawai'i, all of whom should have equal access to
20 appropriate facilities and food subsidies, but this is currently
21 not the case; and

23 WHEREAS, the Department of Education assesses the free and
24 reduced lunch applications of all public school students and
25 determined in the 2016 Title I status reports that seventy
26 percent of the student population of Hawaiian charter schools is
27 considered economically disadvantaged and qualifies for federal
28 food subsidies; and

1 WHEREAS, start-up charter schools have no kitchen
2 facilities, while conversion charter schools may have existing
3 Department of Education kitchen facilities; and
4

5 WHEREAS, some charter schools, especially those in rural
6 areas of Hawai'i, are denied access to National School Lunch
7 Program subsidies because there are no appropriate United States
8 Department of Agriculture certified kitchens besides those
9 existing in Department of Education public schools; and
10

11 WHEREAS, since 2000, the inception of start-up charter
12 schools in Hawai'i, the State Public Charter School Commission
13 has repeatedly requested facilities funding for charter schools;
14 and
15

16 WHEREAS, without United States Department of Agriculture
17 appropriate kitchens in charter schools, low income families are
18 not able to receive federal free and reduced food subsidies that
19 are provided to all other traditional public school families;
20 and
21

22 WHEREAS, without United States Department of Agriculture
23 appropriate kitchens in charter schools, Hawai'i is losing
24 millions of dollars in food subsidies for low income families
25 per year; and
26

27 WHEREAS, the lack of appropriate free and reduced food
28 service severely burdens and adversely impacts charter school
29 families; and
30

31 WHEREAS, beginning 2012, the Department of Education
32 decided that charter schools would no longer have access to the
33 nearest existing Department of Education food service, which
34 effectively resulted in the denial of access to qualified
35 families receiving federal subsidized meals under the United
36 States Department of Agriculture National School Lunch Program;
37 now, therefore,

39 BE IT RESOLVED by the Senate of the Twenty-ninth
40 Legislature of the State of Hawaii, Regular Session of 2018, the
41 House of Representatives concurring, that the Department of
42 Education is urged to ensure that all public school students,

1 including public charter school students, have equal access to
 2 appropriate educational facilities and food service; and
 3

4 BE IT FURTHER RESOLVED that the Department of Education is
 5 requested to immediately provide school breakfasts and lunches
 6 to charter school students who qualify at no additional expense
 7 to the charter school or students; and
 8

9 BE IT FURTHER RESOLVED that the Department of Education is
 10 urged to provide equitable facilities support to charter
 11 schools; and
 12

13 BE IT FURTHER RESOLVED that certified copies of this
 14 Concurrent Resolution be transmitted to the Governor, Chair of
 15 the Board of Education, Superintendent of Education, and
 16 Executive Director of the State Public Charter School
 17 Commission.
