The purpose of this measure is to continue to diversify Hawaii's economy through the promotion of Hawaii's aquaculture industry by appropriating funds for the planning of, and participation of Hawaii's aquaculture industry in, the World Aquaculture Society's Aquaculture America 2020 conference to be held in Honolulu.

The Hawaii Technology Development Corporation, Hawaii Strategic Development Corporation, Kampachi Farms, Marine Genetics, Ulupono Initiative, Aquaculture Planning & Advocacy LLC, Hawaii Farm Bureau, Hawaii Aquaculture and Aquaponics Association, Blue Ocean Mariculture, Oahu County Legislative Priorities Committee of the Democratic Party of Hawaii, and several concerned individuals testified in support of this measure.
