Your Committee on Finance, to which was referred H.B. No. 2466, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND, "

begs leave to report as follows:

The purpose of this measure is to prohibit the Hawaii Employer-Union Health Benefits Trust Fund (Trust Fund) from withholding any retroactive reimbursement payable after June 30, 2013, to a retired employee-beneficiary and qualified employeebeneficiary's spouse from an income-adjusted Medicare Part B premium based on when the adjustment request is made to the Trust Fund.

The United Public Workers, AFSCME, Local 646, AFL-CIO and a concerned individual supported this measure. The Hawaii Employer-Union Health Benefits Trust Fund Board of Trustees opposed this measure.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 2466, H.D. 1, and recommends that it pass Third Reading.
