Sir:

Your Committee on Finance, to which was referred H.R. No. 183, H.D. 1, entitled:

"HOUSE RESOLUTION REQUESTING THE CITY COUNCIL OF THE CITY AND COUNTY OF HONOLULU TO REQUIRE A CONDITIONAL USE PERMIT-MAJOR FOR ANY AND ALL ALLOWED USES ON LANDS IN P-2 GENERAL PRESERVATION DISTRICTS THAT ARE WITHIN ONE HUNDRED FEET OF A RESIDENTIAL ZONED AREA,"

begs leave to report as follows:

The purpose of this measure is to request the City Council of the City and County of Honolulu to require a conditional use permit-major for any and all allowed uses on lands in P-2 General Preservation Districts that are within one hundred feet of a residential zoned area.

Upon further consideration, your Committee has amended this measure to exclude Type A and Type B utility installations from the requirement.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee concurs with the intent and purpose of H.R. No. 183, H.D. 1, as amended herein, and recommends its adoption in the form attached hereto as H.R. No. 183, H.D. 2.
