Your Committee on Transportation, to which was referred H.R. No. 77 entitled:

"HOUSE RESOLUTION URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ALLOW THE COUNTIES TO USE VACANT STATE LANDS AS STORAGE FOR ABANDONED VEHICLES,"


