Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 3002, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO LIBRARIES,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Authorize the State Librarian to designate one or more public library employees to be notaries public; and
- (2) Allow designated employees to perform as notaries public in government service for fees that will be deposited into the library fee for enhanced services special fund.

Your Committee on Conference finds that the Hawaii State Public Library System staff have received requests for notary services, particularly in rural areas of the State. Authorizing the State

Librarian to designate one or more public library employees to be notaries public and allowing public libraries to charge a fee for performing notary services will help assist in providing this much needed service to the public and provide a new source of revenues for the library fee for enhanced services special fund.
