Your Committee on Health & Human Services, to which was referred S.B. No. 738, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH CARE PRACTITIONERS," begs leave to report as follows:

The purpose of this measure is to expand the pool of orthodontists who are eligible to perform orthodontic services for treatment of orofacial anomalies, covered by health insurance, to any licensed dentist who has completed an orthodontic residency program accredited by the Commission on Dental Accreditation.

Lifetime of Smiles Hawaii, American Academy of Pediatrics Hawaii Chapter, and many individuals testified in support of this measure. The Board of Dental Examiners, Department of Health, Hawaii Pacific Health, and Hawaii Medical Service Association provided comments.


Your Committee has amended this measure by:
