Requires the department of health to conduct a study on the Status & impact of aviation noise on residents of the Puna district and **Testimony** surrounding areas of the Hawaii Volcanoes National Park. Appropriates funds to the department of health to conduct the

study.

RELATING TO ENVIRONMENTAL PROTECTION. AEN/CPH, **SB 3095** WAM/EDU

Establishes disclosure and public notification requirements for Status & outdoor application of pesticides in various sensitive areas or by Testimony large-scale, outdoor commercial agricultural operations. Establishes a pilot program that creates a vegetative buffer zone

around five selected schools near a commercial agricultural

production area. Effective July 31, 2018.
