Establishes positions within the agricultural resource management division. Authorizes GO bonds. Makes an appropriation. RELATED TO NEW FARMERS. AEN, WAM **SB 3078** Allows new farmers to receive income tax credits for purchasing Status & or renting agricultural assets through December 31, 2023. Sets Testimony out eligibility requirements to qualify as a new farmer. SB 3087 RELATING TO THE AGRIBUSINESS DEVELOPMENT AEN, WAM CORPORATION. Status & Appropriates funds to the agribusiness development corporation Testimony to identify factors that affect the quality of local papaya and to develop and establish protocols to enhance the marketability of the Hawaiian solo papaya.
