DECISION MAKING ON THE FOLLOWING MEASURE(S):

SB2059 Status and Testimony RELATING TO PUBLIC ACCOUNTANCY.

CPH

Establishes procedures for an out-of-state individual licensed as a certified public accountant or certain accountancy firms to be

granted practice privileges in this State by the board of public accountancy if the licensee or firm meets certain qualifications and requirements for substantial equivalency. Makes conforming amendments to the laws relating to public accountancy to reflect

practice privileges. Takes effect on 1/1/2019.

SB2243

RELATING TO MOTOR VEHICLE REPAIRS.

CPH

Status and Testimony

Prohibits motor vehicle insurers from charging insureds an additional fee for repairs made with original equipment manufacturer parts if the vehicle manufacturer recommends original equipment manufacturer parts.

SB2652

RELATING TO MOTOR VEHICLE INSURANCE.

CPH

Status and Testimony

Allows licensed producers of motor vehicle insurers to satisfy the requirement that insurers provide a complete sales and claims office in the State by instead allowing the licensed producer to

establish and maintain a sales and claims office.

SB2244 SD1 (SSCR2299)

RELATING TO WORKERS' COMPENSATION.

LBR, CPH

Status and Testimony

Requires health care providers in the workers' compensation system who are authorized to prescribe opioids to adopt and maintain policies for informed consent to opioid therapy in circumstances that carry elevated risk of dependency. Establishes limits for concurrent opioid and benzodiazepine prescriptions.

Takes effect 1/1/2045. (SD1)

SB2926 Status and Testimony **RELATING TO DENTISTRY.**

Requires all dental assistants to obtain certification from the Dental [Measure added on Assisting National Board, Inc., as certified dental assistants no later than July 1, 2019, or no later than one hundred twenty days
