HB 1756 Status	RELATING TO PESTICIDES. Bans import, use, manufacture, sale, and storage of chlorpyrifos in the State.	EEP/AGR, CPC, FIN
HB 2722 Status	RELATING TO ENVIRONMENTAL PROTECTION. Prohibits the application of neonicotinoid insecticides and glyphosate herbicides after December 31, 2020, without a license or permit issued by the State on State public lands under certain conditions.	EEP/AGR, CPC, FIN
