Status

Requires DBEDT to adopt rules authorizing distributors to sell gasoline containing up to 10% ethanol.

EEP/TRN, FIN

HB 2728 Status RELATING TO CLEAN ENERGY TRANSPORTATION.

Establishes a Clean Transportation Initiative to reduce and ultimately eliminate the use of fossil fuels in all public ground transportation by 2035, and in all ground transportation, with a near term 2025 target benchmark. Requires the Department of Transportation to collaborate with the Department of Physics Requires Development and

benchmark. Requires the Department of Transportation to collaborate with the Department of Business, Economic Development, and Tourism to achieve the goals of the Clean Transportation Initiative. Clarifies that the transportation objectives of the State Planning Act include the reduction and ultimate elimination of the use of fossil fuels in all public ground transportation by 2035, and in all ground

in all public ground transportation by 2035, and in all ground transportation thereafter. Repeals the Initiative on 1/31/2046.
