RELATING TO ORGANIZATIONAL REPORTS OF CANDIDATE JDC **SB 2153** COMMITTEES. Status & Repeals the requirement that candidate committee Testimony organizational reports include the name and address of each contributor who contributed an aggregate amount of more than \$100 to the candidate committee since the last election. **SB 2154** RELATING TO ORGANIZATIONAL REPORTS OF **JDC** NONCANDIDATE COMMITTEES. Status & Repeals reporting requirement regarding contributions in **Testim**ony organizational reports of noncandidate committees and noncandidate committees making only independent expenditures. **SB 2992** RELATING TO CAMPAIGN FINANCE. **JDC** Clarifies that the definition of "advertisement" as it relates to Status & campaign finance law does not include signs, banners, bumper **Testimony** stickers, and other sundry items. RELATING TO SERVICE ANIMALS. **JDC SB 2461** Establishes the offense of "misrepresentation of a service Status & animal". Changes the term "service dog" to "service animal" Testimony and amends the definition of that term to conform with the Americans with Disabilities Act of 1990. RELATING TO FINANCIAL DISCLOSURE STATEMENTS. **JDC SB 2609** Requires certain information on the financial disclosure Status & statements deemed to be public records for non-paid volunteer **Testimony** members of state boards to be redacted.

Clears up inconsistencies in the processing of expungements and public dissemination of criminal history record information relating to cases in which the defendant is acquitted or charges are dismissed by reason of physical or mental disease, disorder, or defect under chapter 704, Hawaii Revised Statutes, or is involuntarily hospitalized under section 706-607, Hawaii Revised Statutes.
