**SB 2220** RELATING TO EMPLOYMENT PRACTICES. LBR, JDC Prohibits an employer from suspending, discharging, or Status & discriminating against an employee for testing positive for **Testimony** cannabis if the employee is a registered qualifying patient who is authorized for the medical use of cannabis. Provides certain exceptions. RELATING TO CONTRACTORS. LBR, CPH **SB 2376** Raises the threshold under the contractor licensing law's Status & handyman exemption from \$1,000 to \$5,000. **Testimony** RELATING TO STATE EMPLOYEES. LBR, JDC **SB 2610** Adds a definition of "intern" to the State Ethics Code and Status & includes interns among state employees to whom the code **Testimony** applies. RELATING TO ELECTRICAL CONTRACTORS. **SB 2937** LBR, CPH Provides an exemption to the licensing requirements for certain Status & qualified individuals in situations when high voltage (six hundred **Testimony** volts or higher) electrical work is performed while employed by a Hawaii licensed electrical contractor.

RELATING TO THE EMPLOYMENT OF A MINOR. **SB 3044** LBR, CPH

Requires an on-set teacher be present with and accompany a Status & minor under 14 years of age whenever the minor is on set and **Testimony** employed for theatrical purposes.

**SB 3106** RELATING TO INDEPENDENT CONTRACTORS. LBR, JDC

Provides three categories and twelve factors for the department Status & of labor and industrial relations to apply to determine

**Testimony** independent contractor status.
