SB 2571 RELATING TO WATER POLLUTION. WTL/AEN, CPH

Status & Bans the sale, offer of sale, or distribution in the State of any SPF sunscreen protection personal care product that contains

oxybenzone or octinoxate, or both, without a medically-licensed

prescription. Takes effect 1/1/2019.
