

Responsibilities: Provide leadership coordinating state systems of care for the prevention, identification, diagnosis, and treatment of Fetal Alcohol Spectrum Disorders (FASD); serve as the point of contact for families, individuals, agencies and community members, providing information and referral services for FASD issues; expand awareness and knowledge of FASD in Hawaii; facilitate and manage the FASD Task Force; conduct workshops for professionals and at-large community; secure technical assistance and training; serve as State liaison with the National Association of Fetal Alcohol State Coordinators; develop FASD informational materials. Epidemiologist/Evaluator, Big Island Perinatal Health Disparities Project Family Health Services Division, Maternal and Child Health Branch Hawaii Department of Health

Responsibilities: Manage the collection of the National Performance Measure and other project-related data; provide analysis of project data; develop presentations and related materials for dissemination re: project progress and findings; respond to questions and comments from the project's federal Project Officer; write and submit project continuation grant application; monitor deliverables from project funded contracts; provide technical support and training for contractors specific to data collection and reporting requirements; develop small contracts, Request for Information, and Requests for Proposals; evaluate project progress based on Project data. *Supervised 1 FTE*.
