(1) Why do you want to be a member of the Board?

> I was asked to consider volunteering to fill the public member seat so that the Board membership would be full, which relates to quorum voting. Because I now have some time to spare I believe I can assist in achieving one of the Board's goals of revamping the Massage Therapy rules.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

The Board applies applicable statutes and rules to situations that come before it to protect the public on one hand, or to give guidance, administer or support potential or existing Massage Therapists.

(3) In what ways do you feel that you can help protect the consumer?

> Consumer protection can occur through proposing or supporting appropriate legislation, assuring that the rules that apply to Massage Therapists clearly specify qualification and professional behavior requirements, and sanctioning potential or existing Massage Therapists that deviate from those qualifications or behavior.

I am familiar with the legislative process having worked in the Senate Majority Office and later for a Senator.
