### Carol Petith-Zbiciak DNP, APRN-Rx, FNP-BC Nominee for Tri-isle Subarea Health Planning Council Response to Questions

I taught nursing at University of Hawaii Maui College (UHMC) for almost 17 years. I completed my doctor of nursing practice (DNP) degree through University of Hawaii at Manoa in 2016. My dissertation was about closing the gap in health care services for homeless persons on Maui. In February of 2018, I retired from UHMC. I am able to interview persons, gather data, analyze data, draw conclusions, write a document, and collaborate with others — all of which are useful skills for the position.

I would like to learn the processes of the SAC from the more experienced members, appropriately address matters that come before us, and protect the health care interests of the people of Maui County, especially the poor and underserved.
