She served in several administrative roles, including director of maternal newborn NICU services at Baylor All Saints Medical Center in Fort Worth, Texas, and assistant vice president of women and children's services at the Medical Center of Lewisville in Lewisville, Texas.

Kecia brings with her experience from a variety of health care settings that help to inform her decisions and recommendations as an advisory board member. She is incredibly knowledgeable and capable of understanding the larger issues facing the nursing practice. Kecia is a well-liked and trusted colleague who is frequently sought out for her advice. Therefore, she will be an asset to Hawai'i State Center for Nursing Advisory Board.

Accordingly, I urge the committee and the Senate to confirm the appointment of Kecia Kelly for the Hawai'i State Center for Nursing Advisory Board.
