The members' responsibilities will include doing a great deal of research to understand the public health issues of our communities prior to rendering a position.

I am a nurse. I approach situations in life from a nurse's perspective. The nursing profession is inherently founded on the principles of caring and advocating for the patient. Subsequently, my role and professional responsibility is to care, protect, and advocate for the citizens of Hawaii.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

My qualifications include practicing as a Clinical Nurse Specialist for most of my career working in Hawaii; serving military veterans with both medical and mental disorders. I held several public health nurse positions within the State of Hawaii. I cared for diverse populations; from high risk pregnant women to our elderly population. My 34+ years working as a professional nurse in Hawaii has given me first-hand experience about the healthcare needs of our local residents. Currently, I teach nursing studies at the college level and am the Chair of Nursing at Argosy University. I believe that I am a good fit to serve as a member on the Hawaii Statewide Health Coordinating Council.

(5) What do you hope to accomplish during your term of service?

Nurses have much to offer in changing the culture of caring in our State. I would promote more nurses working in areas such as mental health and correctional facilities to make them healthier and safer. Seasoned nurses have excellent assessment skills and know how to connect with patients and disadvantaged individuals. Nurses are not utilized enough in Hawaii for their knowledge and

the art of their practice. I would strive to promote more nurses in positions where they can serve as change-agents to solve the problems of our vulnerable and underserved.

- b) Open-minded to other's opinions and beliefs, always looking to see the bigger picture. A trait needed to fully understand Hawaii's populace.

- (7) Name a previous experience you've had that will be beneficial as a Board member.

This experience that I will explain epitomizes the desire I have to improve the health status of Hawaii people who need someone to speak for them, for they are often not able to help themselves. I live in downtown/Chinatown and see the homeless, mentally ill, and elderly struggling every day. It bothers me that I, as an individual alone, cannot remedy their situation.

The most recent experience I had was on a sidewalk in Chinatown when an elderly gentleman, ambulating with a walker, suddenly fell backwards while attempting to board a city bus. He hit the ground. I quickly moved his walker out of the way so that it did not fall on top of him, preventing further injury. Another pedestrian assisted me to pick up the fallen man. I assessed the elderly man for his injuries, giving him reassurance. However, all the while, I was assessing his needs. I had many questions about his lack of personal hygiene, poor nutritional status, perhaps lack of medication management, what is his support system; and so many more concerns? Is this how we care for our kupuna? Where is the dignity for our elderly in the place we call paradise? My frustration is that as just one person, I feel hopeless in battling the problems I see everyday. Perhaps belonging to a collaborative effort, such as being a member on the Statewide Health Coordinating Council, I could contribute my commitment to make a profound difference in the health of Hawaii's people.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

The leadership at my university has assured me that there is no conflict of interest on their part if I am fortunate enough to be appointed to the Board. If a conflict should arise in the future, I would deal with it swiftly and with the utmost transparency.
