The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM561 and GM562, which will confirm OHA Nominee, Clifford Kapono for terms to run consecutively as the Hāmākua regional representative on the Hawai'i Island Burial Council (HIBC).

Mr. Kapono has genealogical ties to Kohala and has lived most of life in Hāmākua on Moku o Keawe. Mr. Kapono received his BA in International Business from San Francisco State University, his graduate degree in Business at Dartmouth College, and did his PhD studies in International Economics at Krasnoyarsk State University. Throughout his career in business, he focused on Native Hawaiian public health issues specifically affecting the Keaukaha and other Hawai'i Island communities. He has also dedicated much of his professional time to educating young Hawaiians in math and sciences at Keaukaha Community Outreach, Kamehameha Schools Kea'au Campus, New Century Connections Public Charter School, and Hālau Lōkahi Public Charter School. Mr. Kapono has committed substantial time to the revitalization of many Hawaiian practices, including navigation as one of the early members of the Hokūle'a crew in the 1970s and 'aina restoration as a member of the Protect Kaho'olawe 'Ohana. He has also supported Native Hawaiian civic engagement as a voter registrar with the Office of Hawaiian Affairs. Currently, Mr. Kapono seeks to turn his focus toward the protection of Native Hawaiian burials and archaeological resources. Mr. Kapono is a dedicated professional with the desire to preserve Hawaiian ways of knowing and being.

For these reasons, OHA urges the committee to <u>PASS</u> GM561 and GM562 to confirm Mr. Kapono to the Hawai'i Island Burial Council. Mahalo for the opportunity to testify on this important measure.

The Department of Land and Natural Resources (Department) supports Governor's Message 562, nominating Mr. Clifford Kapono to the Island Burial Council, Island of Hawai'i expiring June 30, 2022.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. The Councils determine whether to preserve or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Mr. Kapono is a resident of Hilo. He has a B.A. in International Business from San Francisco University, a MBED from Tuck at Dartmouth College and was a PHD Candidate in International Economics at Krasnoyarsk State University. His professional experience includes VP (South Pacific) of Motorola Communications & Electronics; General Manager of Mid-Pacific Molecular; and CEO of Kapono & Associates Inc. He is currently the CEO of M2M Enterprise Inc. More importantly though, Mr. Kapono has been active in his community. He was a Hokulea crew member; member of the Protect Kahoolawe Ohana; did math tutoring at the Keaukaha Community Outreach; and taught at the Kamehameha Schools, Keaukaha Campus.

In his own words, Clifford Kapono believes that "native Hawaiian people have an authentic responsibility to their ancestors to care forte antiquity that has been given us to share with all the people of Hawaii for the betterment of Moku O Keawe."
