(1) Why do you want to be a member of the Board?

Boards have the potential to make significant positive impacts. I believe this is especially true in Hawaii. I also believe in universal design, where everything is accessible to everyone and everyone benefits. For example, all sidewalks should have cutouts. This not only benefits persons who use wheelchairs and scooters, but those with mobility issues, people pushing strollers, those rolling suitcases, backpacks, or shopping carts, and so on. The raised dots at the cutouts warn those with vision loss that they are entering a crosswalk and also provide traction for when the cutout is wet. Ramps can be used by everyone. They should not be an afterthought that is placed in the back or side of a building; they should be the primary means for entering a building. I would like to provide guidance that would help lead to significant positive impacts not only for persons with disabilities, but for everyone.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

The roles of Board members vary. At any given time they may be advocates, consumers, researchers, educators, brokers, facilitators, organizers, and more, depending on the tasks at hand. Board members are responsible for learning about and understanding the issues faced by persons with all kinds of disabilities. They are responsible for trying to see all perspectives (not just their own) and weigh options carefully in order to provide the best guidance.

(3) In what ways do you feel that you can help protect the consumer?

I humbly believe the mix of my skills and personal experiences can help guide others. I have had to advocate for myself and others in a variety of situations. I've lived in Hawaii for nearly16 years and have visited all of the major islands multiple times. While I still have much to learn, I have a good idea of the issues faced by persons with disabilities across the state.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I had the great fortune to get an extensive higher education. I have a Bachelor of Arts in theater, a Master of Fine Arts in theater, a Bachelor of Science in psychology, a Master of Social Work degree, and a Ph.D. in Social Welfare. (I really took the phrase "Arts and Sciences" to heart.) I've lived in five states, have visited 31 states and the District of Columbia, and 13 countries. I am a social worker, researcher, educator, manager, advocate, and more. I've been in the workforce almost continually for the past 43 years, starting out as a maid in a 13-room motel and working my way up to being Director of a center. Around 2004 I was diagnosed with a disability that limits my mobility. I work at a place that helps to better the lives of persons with disabilities through research and evaluation, education, and community development. More than half of the current staff have one kind of disability or another. I have a wide range of interests and experiences and I feel I would bring a variety of perspectives to the Board.

(5) What do you hope to accomplish during your term of service?

Generally speaking, positive movement forward for those with disabilities, those without, for residents, and for visitors. I understand some of the issues those with disabilities deal with, but before answering with specifics, I need to understand other parameters that may affect what the Board does and how it does it. I need to know what realistically the Board can do and then proceed accordingly from there. All that being said, I would especially like to help employers get over not hiring well-qualified persons with disabilities simply because they have disabilities. Yes, this is illegal, but we all know it happens. Often times this comes out of fear of the unknown. I can lead in this area by example.

- (6) Name three qualities that best describe you and how these qualities will benefit the Board.
  - 1. Stubborn, persistent I don't give up easily, but I know when to back off, too. If you want to get things done, sometimes you've got to be persistent.
  - 2. Able to see and understand perspectives that differ from mine, and objectively determine if the opposing views hold merit. If they do, I am able to change my views accordingly. I try not to let my ego get in the way or get stuck into thinking my way is the only way. There may be something I have not accounted for.
  - 3. Able to get along with and work with just about everyone, even if I don't particularly care for someone (which doesn't happen too often), or if they don't care for me. I focus on our common goals, rather than personality or other differences.
- (7) Name a previous experience you've had that will be beneficial as a Board member.

Since 2003, I have been a member of a local, community-based board. In addition, I have worked on numerous research projects, conferences, community events, committees, and have had a wide range of experiences that should prove beneficial.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

Yes. I am Director of Pacific Disabilities Center at the John A. Burns School of Medicine, University of Hawaii at Mānoa. Once in while, DCAB contracts with us to provide some work for them. In order to avoid conflicts, if the Board is voting on anything that has to do with the Pacific Disabilities Center – monetary or otherwise – I would recuse myself and leave the room. If Pacific Disabilities Center was awarded a contract from DCAB, no portion of my salary would be included in the budget. This situation and the solutions listed above have been vetted and approved by the Hawaii State Ethics Commission. To my knowledge at this time, no other conflicts of interest should arise.
