This letter is in response to your request and the following questions:

- 1. Why do you wish to be a member of the BOD for the HHFDC? I have been serving on the Board for HHFDC since the fall of 2015, as the Kauai representative. I feel that my participation on the Board has had a positive effect on enforcing and creating new policies to streamline the process for the development of affordable housing. It is my hope to continue working with other members of the Board, the Staff and affordable housing developers to create policies and take actions that will increase our ability to produce affordable housing for Kauai and throughout the State.
- 2. How do you perceive the role and responsibilities of a member of the BOD of the HHFDC? As the Kauai Representative, I perceive my role as an advocate for the people of Kauai but also as a general advocate for affordable housing development throughout the State. In order to accomplish this, it is my responsibility to meet regularly with private non-profit and for-profit affordable housing developers, the Kauai Housing Agency and other members of the County administration to understand the short and long term goals of the County and how HHFDC can facilitate the effectuation of those goals. It is also important that I continue meeting with HHFDC staff to develop plans to address the needs of affordable housing Statewide and best utilise the tools that HHFDC has at its disposal. Above all it is essential that the BOD continues to maintain fiscal responsibility for HHFDC and develop policies that fulfill the communities' needs in the most efficient and cost effective way.
- 3. Given your understanding of the role and responsibilities of a member of the BOD of HHFDC, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the BOD of the HHFDC. I was raised with the belief that it is everyone's responsibility to be involved in helping others and to be actively engaged in the work that our government does. My experience working in the private sector in real estate as well as working as the Kauai District Land Agent for the Department of Land and Natural Resources, Land Division, has given me unique insight into the market demands for affordable housing and the complex legal and governmental issues involved in developing and subsidizing housing projects. I have 17 years of experience in property management and sales. I have also served on the Board for other non-profits related to affordable housing development and was the founder of a non-profit Community Land Trust oriented to developing permanently affordable housing options. My base of knowledge in real estate appraisals, real estate laws, property management, and real estate finance have allowed me to quickly understand the complex finance tools and real property assets that the BOD for HHFDC oversees. By combining my real estate knowledge with active community involvement in the County of Kauai, I feel that I can be an effective advocate for my community and for the State assets that HHFDC oversees.
- 4. What do you hope to accomplish during your term of service? The overwhelming need for affordable housing options within the County of Kauai and the State of Hawaii are transparent. It is my goal to help increase the total output of affordable housing units, on Kauai and throughout the State by effective fiscal and policy management. Specifically, I would like to see HHFDC expand its role in off site infrastructure projects that support affordable housing developments.

5. Can you foresee any possible conflicts of interest that could arise during your service on the BOD of the HHFDC? How would you overcome any possible conflicts of interest? At this time, I do not foresee any conflicts of interest. If any come up, they will be disclosed immediately and I will follow the advice of the Hawaii State Ethics Commission.
