1. Why do you wish to be a member of the Board of Directors of the Hawaii Housing Finance and Development Corporation?

I wish to help in increasing the inventory of affordable housing in Hawaii.

2. How do you perceive the role and responsibilities of a member of the Board of Directors of the Hawaii Housing Finance and Development Corporation?

My role is to help breakdown the barriers to affordable housing and encourage new innovative ways to look at affordable housing.

3. Given your understanding of the role and responsibilities of a member of the Board of Directors of the Hawaii Housing Finance and Development Corporation, why do you believe that you are qualified for this position?

All of my life and over the years of working on various projects, working with DHHL, and with other non-profit organizations, and as working as the DPP Director facilitating affordable housing projects in Hawaii, working with developers like Stanford Carr, I have a broad range of experience that I will use in this position.

4. What do you hope to accomplish during your term of service?

The first is to simplify the rules so that more developers can provide affordable housing. Second is to work on financing to help developers provide affordable housing. The third is to encourage DPP and DHHF to work together to think of ways to cut the amount of regulations required for permits to help encourage affordable housing.

I may have conflicts of interest if I am a consultant with developers. In those cases, I would recuse myself from voting or speaking for such developers.
