The purpose of this letter is to express my strong support for The Honorable James H. Ashford to serve as a Judge of the Circuit Court of the First Circuit. I have known Jim since he joined Cades Schutte in 1990 and then had the privilege of being his partner for 17 years until he was appointed by Chief Justice Recktenwald to serve as a Judge for the District Court of the First Circuit in 2013.

The Board of Directors of the Hawaii State Bar Association (HSBA) appreciates the opportunity to submit comments on the nomination of James H. Ashford for the position of Circuit Court Judge of the First Circuit.

The HSBA Board of Directors followed its multi-step process to inform the confirming authority of its findings.

- Notification to the nominee of the HSBA appointment review process, which includes a questionnaire requesting educational credentials, legal and other professional work experiences, personal references; a resume; a copy of the JSC application; a form authorizing disclosure from the Office of Disciplinary Counsel of any disciplinary action; and an interview with the HSBA Board of Directors.
- Notification via electronic transmission to the HSBA membership of the appointment and a request for comments on the nominee.
- Appointment of a three-person review Subcommittee of HSBA Board members by the President, which serves as a neutral fact-finding body to review documentation submitted by the nominee, contact references submitted by the nominee, review comments received from the HSBA membership, and conduct follow-up member contact for clarification, if necessary, for presentation to the HSBA Board.
- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

## Comments:

To whom it may concern,

I'm writing in support of Judge James H. Ashford as nominee to the Circuit Court of the First Circuit.

To put this nomination in context, let me share some relevant personal background. I began my legal career serving as a law clerk to two circuit court judges. I then went into private practice in insurance defense litigation, during which time I appeared before judges in both state and federal courts. I returned to the judiciary to serve as Judge Rhonda Nishimura's judicial assistant until her retirement and have served as judicial assistant to Judge Ashford since August of 2017.

As you may be aware, Judge Ashford was temporarily assigned to handle Judge Nishimura's civil calendar (10th Division) following her retirement. Prior to actually assuming the assignment, Judge Ashford shadowed Judge Nishimura, observing her in court, familiarizing himself with the cases, and participating in settlement conferences. He spent a considerable amount of time discussing with her how best to handle 10th Division's civil calendar as it includes bi-yearly asbestos trials and numerous complex litigation cases. Consequently, the transition from Judge Nishimura to Judge Ashford was quite seamless.

During the course of his time with 10th Division, Judge Ashford has ruled on numerous motions, conducted status and settlement conferences, and even presided over a few trials. Judge is very thorough and well-prepared, sometimes more so than the attorneys. He takes a very practical approach to the handling of cases to facilitate the litigation process and to encourage expeditious resolution of cases. Judge holds both himself and the attorneys appearing before him to a high standard to ensure that the rules of court and the laws of Hawaii are upheld.

Based on my previous experiences and current situation, I believe that Judge Ashford possesses the qualifications to be a successful and effective circuit court judge. He has demonstrated his ability to capably handle the circuit calendar and would be an asset to the circuit court bench. Thank you for your consideration of this testimony.
