
By granting a statewide master contract to SATC, the Department has improved and streamlined delivery of crisis counseling, mental health therapy, and prevention and education outreach services.

Chair Taniguchi, Vice Chair Rhoads, and Members of the Senate Committee on Judiciary:

I am writing to enthusiastically support Russell Suzuki's confirmation as attorney general. I have had many different professional relationships with Russell over the years. In 1986, he was in charge of orienting me at the department of the attorney general. At that time, Russell served the DOE and the UH and I recall sitting in his office waiting my turn to seek his advice. It was before the advent of email and I remember wondering how he could ever get any work done, as the phone was always ringing off the hook in his office.

I soon realized, however, that those non-stop phone calls were a testament to how much Russell's advice was valued—his clients called him constantly as they knew they could count on his sage and practical advice. Russell knew the importance of being responsive to clients who wanted to do the right thing but needed guidance. He imparted legal knowledge and sometimes just as important, practical advice. He was as invaluable to his clients as he was, I later realized, to the entire AG Department.

When Russell became my supervisor and mentor several years later, the values he exemplified in leadership, integrity and collaboration were invaluable. I recall when we realized that a deputy in another division had failed to write the legal brief he had been assigned and the filing deadline loomed the following day. Russell spearheaded a small team of deputies and we stayed up all night writing that brief. We did it solely out of loyalty to Russell who was by our side working that night and into the morning when we triumphantly filed the brief. I recall debriefing (literally) with a pre-dawn breakfast at the Wisteria where we proceeded to blast the deputy who dropped the ball. Russell did not join us in pointing fingers. He was quick to thank us but also to remind us that we are a team and, as a team, we must remember the importance and integrity of the work we do for the department and for the state of Hawai'i. That reminder resonated with us then and continues to do so today.

When I moved from the department of the attorney general to the Hawai'i State Judiciary, the division Russell supervised provided legal representation for the Judiciary. Russell worked with the chief justice, the administrative director of the courts and the staff attorneys office on many different legal matters. He assisted with litigation, legislation, provided consultation and was usually the first person we called upon for legal advice and assistance. We were grateful for his calm and reasoned approach and the guidance he provided on so many different issues.

Russell's intelligence, superb work ethic and integrity are particularly important in a time when our president sees fit to denigrate government departments (DOJ, FBI) with apparent disregard for the adverse morale upon hard working career government workers.

The impact of morale on a department's ability to fulfill its mission cannot be underestimated. TESTIMONY IN OPPOSITION TO GM 638

Senator Taniguchi and members of the Committee on Judiciary,

I want to offer the lonely public dissent to Russell Suzuki's nomination as the Attorney General.

I have nothing against Russell personally. He's a nice guy.

I believe I have only litigated against him in one case. I represented a charter school which was not being provided the funds to which it was legally entitled. We settled the case. Russell insisted on inserting a gag clause in the settlement that prohibited dissemination and discussion of provisions of the settlement – in violation of both HRS chapter 92F and the First Amendment. His insistence on that position was quite troubling, but that is not the reason I am opposing his nomination.

The Attorney General's Office has suffered from long-standing, systemic problems. And Russell Suzuki is not the person to address them. He has served as acting attorney general more than once and served as First Deputy Attorney General (i.e. in a leadership role) under Attorneys General Douglas Chin, David Louie, and Mark Bennett. Based on my experience as well as what I have learned in conversations with various state employees and officials, the Attorney General's Office has often failed to serve the interests of its clients and the public.¹

Failure to Allow Clients to Make Major Litigation Decisions

A lawyer should keep her or his client informed about the status of a lawsuit and should obtain a client's approval for major litigation decisions – such as, whether to appeal a court decision, and whether (and how) to settle a lawsuit. That's a basic professional responsibility. And the Attorney General's Office is required to do so. See Chun v. Bd of Trs. of the Emps.Ret. Sys., 87 Hawai'i 152, 174-75, 952 P.2d 1215 1237-38 (1998) – a case that the Attorney General's Office dislikes and has difficulty following. While there are times when it may be unclear who the attorney general's client is, when a state agency is named as defendant in a lawsuit, that agency needs to be kept informed and must be able to make major litigation decisions.

We know that the Attorney General's office, too often, does not do this.

For example, while the Hawaiian Homes Commission routinely identifies specific cases on its agenda for discussion or consultation with its attorneys, the Board of Land and Natural Resources almost never does. I have sued the BLNR many times and only once has the case been placed on the BLNR's agenda – because a judge required the deputy attorney general to do so. In

that case, the deputy attorney general offered to settle the case even though the BLNR had never been briefed and had never authorized a settlement. Unless the Attorney General's Office is circumventing HRS chapter 92, it cannot discuss a case with a board or commission unless the case is placed on an agenda.

In other situations, the attorney general's office has filed appeals when the affected board never met to discuss the circuit court's decision and never voted to file an appeal. The attorney general's office should not be making these decisions. Its clients should be.

Too often, the Attorney General's Office seeks to set policy rather than to provide legal representation and advice.

Finally, the Attorney General's Office should be informing boards and agencies about relevant court decisions – as well as changes to state statutes. The office routinely does not do so.

Will Russell Suzuki change the long-standing practices of the Attorney General's Office?

Failure to Staff the Island Burial Councils

It is my understanding that every major board or commission is supported by the Attorney General's Office. That means whenever there is a meeting, a deputy attorney general attends. For a few years, the Attorney General's Office attended the meetings of the island burial councils established pursuant to HRS chapter 6E. It is my understanding that no longer occurs. And when the island burial councils disagree with the state historic preservation division, the Attorney General's office refuses to assist the councils – with the one notable exception being *Kaleikini v. Yoshioka*, 124 Hawai'i 53, 283 P.3d 60 (2012) when we forced the Attorney General's Office to do so. Will Russell Suzuki fix this problem?

Environmental Court

Several years ago, the state legislature voted to radically reorganize our court system to create a set of environmental courts. The Attorney General's Office, however, is still organized in the same way that it has been for decades. Those attorneys who litigate in the environmental court should all be in the same division in the Attorney General's Office. It makes much more sense for the attorneys who are supposed to be protecting our natural resources – those that assist the Department of Health and the Department of Land and Natural Resources – to all be in one division. Doing so would enhance enforcement efforts and ensure better coordination.

We've seen no effort by the Attorney General's Office to do so.

Failure to Provide Sound Advice Regarding HRS Chapter 343

The Attorney General's Office is blessed to have a really bright, competent deputy attorney general who advises the Office of Environmental Quality Control and the Environmental Council. Unfortunately, the way the Attorney General's office is set up, when other state agencies seek advice as to how to comply with HRS chapter 343, they ask their own deputy attorneys general, who are not as well versed in that law. And many of these deputy attorneys general provide really bad legal advice to state agencies. It would save everyone a lot of work if

all these agencies could funnel their requests to the deputy who really understands the law. The Office has shown little initiative and creativity in addressing this issue.

Failure to Uphold Trust Obligations

Our courts have ruled over and over again, that the state has public trust duties when it comes to our natural resources. Unfortunately, the Attorney General's Office has failed to impart the lesson from these court decisions to their clients. It has been shocking and disillusioning to witness the Attorney General's Office provide advice to its clients and take positions in court that are antithetical to public trust interests. For example, in *Gold Coast Neighborhood Ass'n v. State*, 140 Hawai'i 437, 403 P.3d 214, the Attorney General's Office disclaimed interest in property vital to public access. The Water Commission's decisions have been reversed virtually every single time, thanks to bad advice from the Attorney General's Office. Will Russell Suzuki change this attitude?

Bad Advice

Lawyers disagree. Some lawyers are better than others. There are some really good attorneys in the Attorney General's Office. But I have been appalled at the quality of the advice that the Attorney General's Office has provided when it comes to issues of stewardship of natural and cultural resources and public participation in decisionmaking. And the quality of this advice has been borne out by the number of cases that the Attorney General's Office has lost. Here's a partial list: Sierra Club v. DOT, 115 Hawai'i 299, 167 P.3d 292 (2007); Kaleikini v. Thielen, 124 Hawai'i 1, 237 P.3d 1067 (2010); In re Petition to Amend Interim Instream Flow Standards for Waikamoi, 128 Hawai'i 497, 291 P.3d 395 (ICA 2012); In re 'Īao Ground Water Mgmt. Area High-Level Source Water Use Permit Applications & Petition, 128 Hawai'i 228, 287 P.3d 129 (2012); Kaleikini v. Yoshioka, 128 Hawai'i 53, 56, 283 P.3d 60, 63 (2012); Blake v. Cnty. of Kaua'i Planning Comm'n, 131 Hawa'i 123, 127, 315 P.3d 749, 753 (2013); Diamond v. Dobbin, 132 Hawai'i 9, 35, 319 P.3d 1017, 1043 (2014); Mauna Kea Anaina Hou v. Bd. of Land & Natural Res., 136 Hawai'i 376, 363 P.3d 224 (2015).

When will this systemic problem be addressed?

Out of date rules

The Attorney General's Office should be proactive. Hawai'i Supreme Court decisions over the past few decades have rendered agency's rules of practice and procedure woefully out-of-date. But the office has taken no visible action to get agencies to update their rules. For example, the Board of Agriculture's rules pertaining to contested case hearings need to be amended in light of Pele Defense Fund v. Puna Geothermal Venture, 77 Hawai'i 64, 881 P.2d 1210 (1994) and In re Maui Elec. Co., 141 Hawai'i 249, 408 P.3d 1 (2017).

I'm not convinced that Russell Suzuki is the person to address these issues, and that's why I'm opposing his nomination.
