Chair Nishihara, Vice Chair Wakai, and Members of the Senate Committee on Public Safety, Intergovernmental, and Military Affairs,

Thank you for providing the Crime Victim Compensation Commission ("Commission") with the opportunity to testify before you today. The Commission strongly supports the appointment of Martha Ross to serve as a Commission, for a term to expire on June 30, 2022.

Ms. Ross has over twenty (20) years of experience in policy, administration, research, advocacy, counseling, and writings relating to violence prevention, victim-witness assistance, and crime victimization.

The Commission is a quasi-judicial body that assists victims of violent crime by providing compensation for crime-related expenses. The Commission also administers a Restitution Recovery Project, under the Justice Reinvestment Initiative, to collect restitution from inmates and parolees and to disburse the collected funds to crime victims. Commissioners hear appeals from administrative decisions ordering or denying compensation and set policy for the determination of claims submitted to the Commission. Special areas of concern in the past have been the treatment of sexual assault and domestic violence victims and enhancing the delivery of compensation services to underserved victim populations. An ongoing concern for the Commissioners is the sustainable fiscal self-sufficiency of the Commission. The Commission's core mission is solely funded through special funds and federal matching Victim of Crime Act (VOCA) funds.

Commissioners must be knowledgeable about the impact of violent crime on individuals and be sensitive and compassionate in dealing with these individuals.

Ms. Ross served as an Interim Commission from 2014-2015 and was appointed as a Commissioner from July 1, 2015. She is a very knowledgeable, experienced, and compassionate advocate for crime victims with specialized expertise in advocacy, counseling, research and policy with victim populations, and treatment services of sexual assault and domestic abuse survivors.

Ms. Ross has a wealth of experience and a deep understanding of victim advocacy, government, and our community. In 1987, Ms. Ross established and coordinated the Victim-Witness Assistance Volunteer Program and served as an effective advocate and counselor for victims and witnesses of violent crimes with Victim/Witness Kokua Services in the Department of the Prosecuting Attorney, City and County of Honolulu.

As an accomplished researcher, trainer, and instructor (adjunct faculty for the University of Hawai'i School of Social Work and lecturer at Chaminade University), Ms. Ross has authored numerous publications relating to violence and victims, violence prevention, restraining orders, access to justice, bias in social work intervention with battered women, and school-based violence prevention. Ms. Ross co-founded and co-facilitated Maluhia O'Wahine, the first counseling-educational support group for battered women on O'ahu. She has served as Executive Director of the Hawai'i State Commission on the Status of Women and of the Violence Prevention Consortium, and as President of the Awareness Foundation. While working at the Sex Abuse Treatment Center as an Administrative Coordinator, Ms. Ross was responsible for community and government relations, medical-legal services and interdisciplinary team management, and policy and grant writing.

During her sixteen (16) years with the Office of Hawaiian Affairs (OHA) championing Native Hawaiian empowerment, Ms. Ross was appointed as the first Bureau Chief and opened and led OHA's Washington, D.C., Bureau. While there, she successfully helped found Ke Ali'i Maka'ainana Hawaiian Civil Club, the first such club in the Washington, D.C., Virginia, and Maryland areas.

After a stint as Vice President of Programs with the Hawai'i Community Foundation, Ms. Ross immersed herself by giving back to the community where she lives by co-creating and helping to set up the Waimanalo Market Co-op where she served as the General Manager and Vice President. The Co-op was set up as a community-driven Waimanalo consumer cooperative and entrepreneur incubator.

Ms. Ross' background, training, and experience have been invaluable to the Commission's efforts to provide equitable and efficient services to Hawaii's violent crime victims during her interim appointment and first term as a Commissioner. The Commission looks forward to continuing to have Ms. Ross' guidance as a Commissioner.

The Commission strongly urges you to confirm Ms. Ross' appointment for a second term as a Commissioner to the Commission.

The trajectory of her 31 years career committed to victim education/protection/advocacy makes Martha Ross an exemplary nominee for continuance on the Crime Victim Compensation Commission.

In 2003 Hawaiians and Hawaiians at heart residing in the Washington D.C. metropolitan area developed a powerful relationship with the Office of Hawaiian Affairs through the newly positioned DC Bureau Chief, Martha Ross. Under her tutelage and example, this community polished skills in applied leadership, advocacy, team work, negotiation and coalition mobilization. DC Hawaiians were introduced to a most effective tool – resolution writing; the cornerstone of grassroots intervention for civic minded organizations like the Association of Hawaiian Civic Clubs.

In 2003 the Office of Hawaiian Affairs and Royal Benevolent Society's education campaign became the catalyst for a joint 2006 decision by Alan Hantman, the U.S. Architect of the Capitol, and the U.S. Congress to move the Kamehameha I statue from its position in Statuary Hall to the newly built U.S. Capitol Visitor Center, Emancipation Hall, Washington, D.C. Martha Ross's intervention to include area Hawaiians in the transition; to witness, to present protocol during the dismantling and reassembling of the Kamehameha I statue was instrumental and formed a lasting relationship between the Office of the U.S. Architect of the Capitol and area Hawaiian organizations. Washington, D.C. area Hawai'i focused organizations continue to steward Hawai'i's two statues within The National Statuary Hall Collection; King Kamehameha I and Saint Damien, culminating in the annual June Kamehameha Lei Draping Ceremony.

During her tenure as the Office of Hawaiian Affairs DC Bureau Chief Martha Ross resolved to address a multitude of inquiries about Ali`i diplomatic business throughout the world, including nation-to-nation missions to Washington, D.C. The Office of Hawaiian Affairs under the guidance of DC Bureau Chief Martha Ross partnered with Ke Ali`i Maka`ainana Hawaiian Civic Club of Washington, D.C. and many community volunteers to work collaboratively on the Ali`i Diplomatic Missions and Other Business Travel to Washington, D.C. The purpose of this project was to learn more about nation-to-nation diplomatic missions to Washington, D.C. directed by Native Hawaiian Ali`i; chiefs, kings, queens – leaders of the indigenous sovereign nation of Hawai`i; and to share our findings. The publication of Ali`i Diplomatic Missions and Other Business Travel to Washington, D.C. - Phase I in May 2006 started with Timothy Ha`alilio as he

departed Hawai`i in 1842. Phase II, published in June 2009 dated Queen Consort Emma Rooke's diplomatic travel in 1866 and concluded with Queen Lili`uokalani's diplomatic travel through 1910.

Martha Ross's example of community engagement, empowerment, advocacy, expansion and sustainability continues to drive the work of Ke Ali'i Maka'ainana Hawaiian Civic Club of Washington, D.C. as we monitor and access policymakers and affiliates deliberating on federal legislation impacting Native Hawaiian culture, health, economic development, education, social welfare and nationhood. Martha Ross's acumen in community initiatives, programs and aspirations fuel small and large Hawai'i focused organizations' memberships to 'imi 'ike (seek knowledge), laulima (work cooperatively), lokomaika'i (share), na 'aupono (possess a deep sense of justice), malama (care for each other), ha'a ha'a (be humble) and to be pono (be moral and proper).

Good afternoon Chair Nishihara, Vice Chair Wakai, and members of the Senate Committee on Public Safety, Intergovernmental, and Military Affairs:

The Sex Abuse Treatment Center (SATC) strongly supports G.M. 642, nominating Martha Ross for the Senate's consideration and confirmation as a member of the Crime Victim Compensation Commission.

The Commission's purpose is to mitigate the financial impact suffered by survivors of violent crime as a result of physical or emotional injury, or death. Every year the Commission manages more than \$1 million in collected assessments against convicted criminals and matching federal funds, and processes approximately a thousand victim compensation payments.

The Commission also engages in ongoing programs that materially improve how survivors are treated in Hawai'i by reducing the cost of medical expenses; holding convicted offenders accountable for making compensation and restitution payments; and ensuring that our criminal justice system remains mindful of survivors' needs for adequate safety planning, timely notification of offender status changes, and other system-based services.

Therefore, it is critically important that each Commissioner be an experienced and talented administrator, and have a keen understanding of the challenges that face survivors of crime and their loved ones.

Ms. Ross is exactly this sort of person. She is a considerate, thoughtful and responsible decision maker and problem solver, with an unparalleled professional understanding of the needs of victims and what they face as they recover from violent crime.

During her years as SATC's Administrative Coordinator and Manager of Medical-Legal Services, Ms. Ross was crucial to ensuring the success of our mission to provide crisis intervention and mental health care for survivors of sexual assault, and was instrumental in handling SATC's relationships with our many government and community partners.

As Executive Director of the Hawai'i State Commission on the Status of Women, Ms. Ross continued to be an untiring advocate for survivors. In that role, we witnessed Ms. Ross bridging the interconnected statewide policies addressing sexual violence and other, often related issues facing local women.

It is further our belief that Ms. Ross's long service with the Office of Hawaiian Affairs, including representing that agency on a national stage, has uniquely qualified her to address many important and sensitive issues that are encountered when ensuring that victims of crime in our diverse, multicultural State receive needed care.

Since 2015, Ms. Ross has served as a member of the Commission. During Ms. Ross's tenure, the Commission has experienced significant success in partnership with the Department of Public Safety (the Department) to increase the collection of court-ordered victim restitution from offenders under the Department's custody and supervision. Additionally, during this period, the Commission has taken strong, affirmative steps to assist the Department in implementing impact-of-crime programs for offenders and maintaining the integrity of post-conviction victim notification services.

Given Ms. Ross's superb credentials as an administrator and expert regarding crime victimization and social justice, it is SATC's privilege to strongly support her confirmation to continue serving the State of Hawai'i as a Member of the Crime Victim Compensation Commission.



#### Testimony in support of MARTHA ROSS to the Crime Victim Compensation Commission

Thank you for this opportunity to submit testimony in support of the appointment of Gubernatorial nominee MARTHA ROSS to serve on the Crime Victim Compensation Commission.

Citizen involvement in volunteer government service is an integral part of a healthy democracy. Martha Ross is one such volunteer having already served four years with the Crime Victim Compensation Commission. The Governor has nominated her for a second term, and I fully support her reappointment.

My name is Jo Kamae Byrne and I am President of Honolulu Information Service, Inc., a Hawaii public records research company established in 1982 to provide business related services in Hawaii and throughout the mainland United States. Additionally, I have also been a community advocate for women and children through the Hawaii Women's Political Cause, Volunteer Legal Services Hawaii and other community groups.

I met Martha Ross when we were both social activists working to improve government support for women and children. Martha was the Executive Director of the State Commission on the Status of Women and subsequently joined the Office of Hawaiian Affairs. One of her significant contributions to OHA was successfully establishing their Washington, D.C. office.

With Martha's background as a social worker and her varied experience in public service, Martha Ross is an ideal candidate to serve on the Crime Victim Compensation Commission. I fully support the Governor's nomination and urge the Committee to approve her appointment.
