She and I were roommates in seminary, and we now serve as ministers on Kauai. In addition, we have served together on several committees in the United Church of Christ.

Rev. Meighen's moral character and ethical conduct are above reproach. Indeed, as a Christian pastor, she serves as role model, teacher, and encourager of high Christian moral principles and conduct in public and private life.

Rev. Meighen's commitment to persons with disabilities is both personal and professional. Her youngest brother has Down syndrome, for whom she is guardian and advocate. After many years serving as Winners' president, she was called into Christian ministry. In that capacity she founded an ecumenical ministry called John 17:21 on Oʻahu. The ministry reaches out to bring together persons with disabilities and churches in worship, fellowship, and mission. I understand from her that there are more than 30 churches collaborating in this ministry.

For the above reasons, I urge you to approve the nomination of the Rev. Dr. Phyllis Meighen to the Disability and Communication Access Board.

This testimony is to support of the nomination of the Rev. Dr. Phyllis A. Meighen to the Hawaii Disability and Communication Access Board. She and I have been friends since 1976, when her brother with developmental disability was placed in our family's adult foster care home in Kailua. She has also been my supervisor for an employment development program she started, my professor in special education, and my colleague in John 17:21 Ministries. Currently, we are fast friends and housemates living in Lihue.

Reflecting on the many settings and roles we have shared over the past 42 years, I'd like to share my observations about Phyllis' character and heart. I think, first of all, of how much she loves to learn. She approaches new situations and new people with an attitude of exploration and inquiry, rather than judgment or fear. This quality has been supportive in her being a pioneer in community-based training for

people with disabilities in Hawai`i. Her enthusiasm for learning is infectious and invites others to expand their thinking to try new ways of working with people, especially those who have significant disabilities.

Second, I'm struck by how her core convictions for living are reflected in all aspects of her professional work and personal life. Phyllis' core convictions include the

beliefs that: a) all people are created in the image of God and have something of value to offer the world; b) our communities should be flexible and open to welcome all people in dignified, respectful, and life-giving ways; and c) her mission in life is to be part of God's work to create communities that work for everyone.

Third, Phyllis is deeply principled, fair minded, and caring in her relationships with people. She is trustworthy with sensitive information and with responsibility for a

broad scope of concern. She seeks creative solutions for problems, divergent views, and conflicts.

Pioneer, leader, teacher, and community reformer are qualities Phyllis Meighen brings to the Disability and Communication Access Board. I encourage you to approve her nomination.
