The Department of Land and Natural Resources (Department) supports Governor's Message 672, nominating Mr. Eldon Pate-Kahakalau to the Island Burial Council, Island of Hawai'i, expiring June 30, 2020.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. The Councils determine whether to preserve in place or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Mr. Pate-Kahakalau is the co-founder and instructor of Kanu O Ka 'Āina Charter School. He comes from a strong family background in education, and is very well-versed in his Hawaiian culture and history. His experience provides him with knowledge of the processes of government and its laws, more specifically, the statutes and administrative rules relating to the treatment of iwi kupuna. Mr. Pate-Kahakalau previously served on the Hawaii Island Burial Council as both a member and Chairperson. He exhibited exemplary leadership and has won the respect and aloha of his fellow members.

Senate confirmation will ensure that Mr. Pate-Kahakalau's esteemed knowledge and perspective emerges during the deliberations of the Hawai'i Island Burial Council until June 30, 2020.
