I am writing in **whole-hearted support of the confirmation of Catherine Payne** to serve as an At-Large Member and Chair of the Board of Education. Catherine served as Principal of Olomana School prior to serving as principal for 14 years at Farrington High School. She has been a staunch advocate for all students creating the best opportunities for those in marginalized communities. In her retirement, she consults and coaches school leaders going through accreditation and serves as the Chair of the Charter School Commission expanding her legacy of improving education for all children of Hawaii.

I have known Catherine on a professional and personal level for over 20 years where she has been a mentor, sponsor, and friend to me and my family.

In 1997, I first got to know Catherine when I was the Director of Facilities for New Hope Oahu. Together, we developed a public – private partnership with the school to create a win-win situation by helping clean up and improve the facilities of Farrington High School for many years without the use of public funds. Over the course of 10 years, New Hope Oahu invested millions of dollars in equipment and sweat equity that improved the school and helped the kids at Farrington. It was Catherine's "out of the box" thinking and collaborative nature that led to a great community partnership.

In 2007 after completing my graduate education I moved back to Hawaii. At the time, she took an unconventional approach to restructure the school by empowering the school leaders to develop a plan that would serve the needs of all students. As a result, she developed a large school into 8 Smaller Learning Academies where each student could find their niche and develop a major in high school that would lead them to be ready for the work place and/or college



readiness. This prevented kids from falling through the cracks and received greater achievement scores in the long haul.

I can personally attest to her character, wisdom, vision, and compassion. I know beyond a doubt that Catherine will make an exceptional Board of Education Chair advocating for an innovative educational future for all of Hawaii's children.

Dear Senator Kidani:

In the sunset of my teaching career, I am honored to provide you with a personalized description of the skills, abilities and experiences that characterize Catherine Payne as the most distinguished candidate for the office of Board of Education Chair. I have taught at Olomana School since 1980, and was extremely lucky to have flourished under Catherine's leadership when she became principal in 1986. During this period, her administrative duties exploded with every successive year of her tenure. Initially, her oversight included the bulging population of incarcerated youth at the Hawaii Youth Correctional Facility in Kailua; students at the Olomana Youth Center, the Windward District's alternative school across the street; the Family Court's detained and sheltered youth at Hale Ho'omalu in downtown Honolulu; and the Adolescent Unit patients at the Hawaii State Hospital in Kaneohe. In subsequent years, she was also tasked with supervision of educational programs at additional state and private agencies: a partial day program at the Key Project in Kahaluu, a Girls Program for psychiatrically fragile high schoolers in Waimanalo, the adolescent psychiatric program at Castle Medical Center, the emerging Kailana/Marimed Program that addressed youth with substance abuse and related emotional problems in Kaneohe, and educational services for youth who had been waived to the Oahu and Women's Community Correctional Centers. She also collaborated in multi-agency discussions related to educational programming for the new Bobby Benson Center, a residential drug treatment program for adolescents. Providing the educational services for these variously challenged student groups meant communicating, collaborating, and cooperating with the administration and staffs of multiple agencies and departments, each with separate missions, priorities, policies and procedures.

Despite these increasing demands, Catherine emulated a strong conviction to serve these diverse populations. Full of unwavering hope that we could divert these youth and make a difference in their lives, she inspired all of us to do the impossible. From having incarcerated youth perform Shakespeare, to reciting historical oratory, to hosting Christmas parties for senior citizens in the locked facility; she held the bar high and expected that our students receive the same quality-driven educational programs as their peers in mainstream schools. A harbinger of the current Zeitgeist, she encouraged and supported innovation and interdisciplinary studies and crafted collaboration schedules to allow teachers time to develop

curricula and pursue innovation. All of this with severely limited resources in staffing and budget, yet inspiring and empowering us to develop programs to help our students.

She engendered in all of us a collective fidelity to this purpose and Olomana School flourished. The Art Team distinguished students by consistently winning Scholastic Art awards, science classes experienced hands-on dissections, English and Social Studies integrated their programs to provide real life experiences in resolving community problems, and the vocational arts programs expanded their reach in providing service to networks in the community. Mindful of the diverse needs of our students who had experienced disruptions in their education, she advocated and successfully installed Adult Basic Education diploma programs to provide expanded opportunities for them to complete their education. Finally, it was through her support that Olomana School was able to realize our first 4-year college graduates; one has her PhD in Hospital Administration and is an Assistant Professor in Physiology at Hawaii Pacific University!

On a personal level, Catherine has been my enduring inspiration in my growth as a teacher. To her credit, I have gained the confidence to take risks and pursue ideas to benefit my students. One that has endured has been her help and guidance in developing my skills as a grant writer. At a time when Olomana School received marginal funding to maintain staffing and programs, she encouraged me to apply for grants to enrich our programs. A hands-on leader and former English teacher, she worked with me to edit my writing and taught me to improve the clarity and focus of my proposals. Ultimately, I was able to write several grants to fund curricular innovation that generated more than \$300K to build interdisciplinary learning teams. Years later, the seeds of her guidance and beliefs were fundamental in inspiring me to write a federal grant that awarded nearly a million dollars for us to build a schoolwide curriculum based on native Hawaiian cultural competence.

Charitable by nature, Catherine always extended herself in her support of an after-school program where I worked with students on citizenship and credit recoupment. Her commitment was profound: helping wash cars, unloading recyclables, and helping to run a polling precinct as we fundraised. It was her unspoken message to me, my colleagues and the students, that her interest and support were genuine. She inspired and taught all of us to "dream big" and have courage to try. Her integrity in her role as principal contributed significantly to changing the belief systems of our students. For the first time, they actually began to believe that they could go to college. To a serious felony offender who could have been waived to adult prison, this belief transformed him into a voracious reader, writer, artist, and poet during his incarceration. Catherine took the time to attend his graduation and family celebration from Kahuku High School. This change in the belief system of our students, that they can be competitive in college, is now a part of the school culture.

Her unwavering faith in developing and inspiring staff has resulted in the attainment of many milestones during her principalship at Olomana. The school at the Hawaii Youth Correctional Facility received annual recognition for the remarkable academic achievement that often exceeded two years of growth in reading and mathematics in Title I reports, and for their weekly Values Education program that was also integrated into the Halawa Correctional Facility's education program. Their integrated science program also won a GTE grant to teach the incarcerated youth orchid cloning. The Detention Home school staff initiated a chess competition with the Family Court judges to provide the youth with more normalized

experiences with the judiciary, and she encouraged collaboration between the teachers and Youth Correctional Facility to assure a more seamless system of supports. To this end, she created and dedicated a Transition Teacher position to prepare youth exiting corrections with additional employment supports and academic links to ensure their success in the community. This teacher received the Hawaii Jefferson Humanitarian Award for outstanding public service for his unorthodox commitment to these incarcerated students, shackling himself like his clients as they went for interviews or applied to college in the community.

From Catherine's seminal work at Olomana School, her steadfast influence, her resolute belief in the power of people when their creativity and commitment are valued, remain in the internalized belief systems of those of us who were so fortunate to have grown through her leadership. Her unwavering belief in my abilities has grounded me throughout my teaching career. It was humbling that I was recognized as a 1997 Hawaii Milken Educator, the 1999 Hawaii State Teacher of the Year, and the Hawaii JC Penney Golden Rule awardee in 2000. In 1999, Olomana School received one of 10 national Points of Light honors at the White House. Clearly, if Catherine had not planted the seeds of possibility thinking, we would not have dared to begin to believe in ourselves and feel empowered to make a difference in educating our very special students.

Her impact on public education continues to resonate among educators in the State of Hawaii. The media has chronicled her tenacious resolve to transform Farrington High School's climate and her educational reforms have gained national recognition; her hallmark continues to be her fidelity to improve Hawaii education, evidenced in her support of community groups such as Adult Friends for Youth to redirect and restore delinquent youth, and her current focus as the Chair of the Charter School Commission to raise the quality of charter schools to ensure parity for these youngsters educationally.

That Catherine Payne has demonstrated over her lifetime a profound commitment to improve the educational programs for the children of Hawaii while engendering the collaboration of her constituents and colleagues underscores her selection as the incontrovertible candidate for the position of the DOE's State Schools Superintendent. She will work tirelessly to ensure that education in Hawaii moves forward, unfettered, and focused on creating effective systems that will produce career and college ready students for the 21st Century.

Aloha Senator Kidani,

I write in support of Governor Ige's nomination of Catherine Payne to be the next Chair of our Board of Education. I also speak on behalf of Ted Dintersmith, the Executive Producer of the acclaimed documentary, "Most Likely to Succeed," and the author of a new book, "What School Could Be." Ted just concluded his 7th visit to Hawai'i and is now on a multi-state book tour. While in Hawaii he met with Governor Ige and First Lady Ige, Superintendent Kishimoto and Executive Director Thompson. He also conducted two workshops at the HAIS 2nd annual Leading Schools of the Future Conference. Ted enthusiastically supports Catherine's nomination.

We believe Catherine Payne is the perfect choice for this particular moment in Hawai'i's education history. She will be, we believe, that leader who knows what school could be, and what a 21st century school needs to look, sound and feel like in Hawai'i. Catherine has been up front and straight about her support for Superintendent Kishimoto, and her three pillars: student voice, teacher collaboration and school design. Ted and I believe that Dr. Kishimoto will be one of the best superintendents in our history, but we need to support her work, and Catherine will lead the way.

I first met Catherine when we were in graduate school together at UH Manoa CoE. I believe that was 1999. At the time I was working on my masters in education foundations. While we were in graduate school together, Catherine shared many stories about her years as principal at Farrington High School. In the years since, I cannot count the number of people who have praised her work at Farrington, and expressed admiration for her deep knowledge of what school is, and what it could be.

Similarly, over the past two years many people have expressed admiration for her work as a board member for the Education Institute of Hawai'i. I had the opportunity to make a direct pitch to EIH to support the making of my own education documentary, <u>Ka Helena A'o: The Learning Walk</u>. Catherine supported my efforts because she knew that education in Hawai'i will meet the challenges of the 21st century, this Age of Acceleration and Innovation, through stories of affirmation and imagination, which is what my film does.

I am a co-writer of the successful application by <u>SEEQS.org</u> for a public charter. I studied our charter school movement under Professor Mary Anne Raywid at the University of Hawai'i at Manoa. I believe through Catherine's leadership, our charters will enter into a new era of cooperation with our public schools. There are many issues to solve; Catherine is an especially good choice given her charter background.

Though this is hearsay, I recognize, I say with confidence that Catherine's integrity, her curiosity DNA, her determination, her kindness and compassion, and most of all, her leadership qualities, make her the talk of the town in education circles. Though Chair Mizumoto has done great things - supporting our ESSA plan, the hiring of Dr. Kishimoto, the ratification of our Blueprint for Public Education - Catherine Payne, with her deep appreciation for the idea that Hawai'i is at an inflection point, and that we can, as Ted has stated on every island, "out Finland, Finland" in five years or less, is the right choice to be our next Chair of the Board of Education.
