My name is Diana Hamasaki, Information Technology Manager at the University of Hawaii. I would like to submit this testimony in support of Director Dwight Takeno's confirmation to the Board of Education.


My name is David Oride and I am currently the Vice Chair of the University Laboratory School's (ULS) Governing Board.


