My name is Amy Agbayani, I am submitting testimony as chair of the Filipina Advocacy Network (FAN). FAN seeks to improve the status of Filipinos and inclusion of Filipinos in education and policy-making bodies. We are in strong support of Edmund Aczon's nomination and reappointment to the Land Use Commission. I have known Mr. Aczon for over three decades. We have worked together in various community organizations (e.g. Hawai'i Friends of Civil Rights, Filipino Community Center and the National Association of Filipino American Associations, Hawai'i Democratic Party). I am now an Emeritus Assistant Vice Chancellor for Student Diversity and during my tenure at the University of Hawai'i, Mr. Aczon helped me with activities to encourage under-represented students to participate in job training programs, community college and Manoa academic programs and careers.

Although Mr. Aczon is best known for his leadership and service with statewide labor organizations, policies related to our economy and workforce, my comments will focus on his leadership within the Filipino community and his efforts to increase representation and success of Filipinos in Hawai'i, a group that is generally under-represented in public and private sector management and policy making boards. I believe representation and diversity on boards is fair and results in better policies for our community. It is my understanding that Mr. Aczon is the only Filipino member of the Land Use Commission. Mr. Aczon will add ethnic diversity and his competence and experience to the board. The Filipino community sees the need to get more Filipino college graduates, more professionals in government and private business, more appointed to policy making bodies.

For a brief summary of Filipinos in the state and in education, I am including the following quote from bills relating to the UH Pamantasan Council:

"The legislature finds that the Filipino community has grown since the first immigrants came to Hawaii in 1906. According to the United States Census, people of Filipino ancestry are the second largest ethnic group in Hawai'i, with fifteen per cent of residents identifying themselves as Filipino alone and twentyfive per cent of residents identifying themselves as Filipino and another race. Students of Filipino ancestry are also the second largest ethnic group in the department of education and represent more than half of the student population at Farrington high school, Waipahu high school, and Lanai high and elementary school.

The legislature also finds that, despite their high representation in the general population and schools within the department of education, students of Filipino ancestry are underrepresented in the University of Hawaii system. Filipino students comprise only twelve per cent of the entire University of Hawaii system student population. Six per cent of the community colleges faculty and two and a half per cent of the University of Hawaii at Manoa faculty are of Filipino ancestry. The fifteen per cent postsecondary degree rate held by Filipinos is the lowest among all ethnic groups in Hawaii. "

We are extremely proud of Mr. Aczon's past accomplishments and service to the state. For over three decades, Mr. Aczon has demonstrated his competence, integrity, and active community leadership and he will continue to be a responsible and independent member of the Land Use Commission. I would like to take this opportunity to publicly thank him for his significant contributions to improve the status and representation of Filipinos in Hawai'i. He has a deep appreciation of the history of our state and our future. I respectfully ask you to confirm his nomination to be re-appointed to the Land Use Commission.

Thank you for your letter dated April 3, 2018 informing me of my nomination to the Land Use Commission by Governor David Ige for another term.

Per your request, here are my responses to your questionnaires:

- Q1: Please describe your understanding of the role and jurisdiction of the Land Use Commission (Commission).
- A1: The Commission's primary role and jurisdiction is to ensure that areas of state concern are addressed and considered in the land use decision-making process. The Commission establishes the district boundaries for the entire state. The Commission acts on petitions for boundary changes submitted by private landowners, developers and State and county agencies. The Commission also acts on request for special use permits within the Agricultural and Rural Districts.

- Q2: How do you perceive the role and responsibilities of a member of the Commission?
- A2: The members of the Land Use Commission have a challenging role and responsibility to the people of Hawaii. My experience in the construction industry-as a former general contractor, former president of the Building Industry Association of Hawaii and former staff member of the Hawaii Regional Council of Carpenters-has allowed me to gain knowledge of land use rules, regulations, policies and procedures. Moreover, my experience in the industry has allowed me to understand important community and government issues involved in such cultural. the land use process, environmental. business/economic and social factors that can potentially impact the proposals the Commission considers.

Having been a member of the Commission for the past four years, I know occasionally, meetings can be personal and emotionally charged. I view serving on the Commission to be an important and serious responsibility.

- Q3: Why do you wish to continue serving as a member of the Commission? Please note if you initially applied to be nominated to the Commission or if you were invited to apply.
- A3: I am honored to be asked and reappointed by the Governor to serve a second term as a member of the Land Use Commission. I welcome this opportunity to serve our community and ensure that the Commission balances the interest of private landowners, developers, government, and the community in making decision about land use in Hawaii.
- Q4: Please describe why you believe that you are qualified to be a member of the Commission, including your designation as representing the City & County of Honolulu. Please discuss any skills, expertise, knowledge, or volunteer involvement that would aid in your decision-making ability.

A4: Based on my understanding of the role and responsibilities of LUC members, I believe that I have the knowledge, skills, and abilities to effectively meet the needs of this serious responsibility.

I am a former general contractor and worked for the United States Senate for 10 years. I also worked for the Hawaii Regional Council of Carpenters as their Community Relations Director/Manpower Specialist. I am currently the Executive Director for the Hawaii Carpenters Apprenticeship and Training Fund. With public/private/labor experiences and various involvement in the community, I am knowledgeable about a wide range of issues that affect private landowners, developers, the community, and State and county agencies. I am able to work with all parties to achieve common goals. I give my 110% to any project I take on. I am confident that I can effectively fulfill the responsibilities of serving as a member of the Land Use Commission.

- Q5: What are some of your accomplishments as a member of the Commission and what would you like to accomplish during an additional term?
- A5: During my first term, I was honored to chair the Commission for two consecutive years. We focused on transparency by revising some of our rules and upgrading our computer system. We made some difficult decisions but based only on true facts and evidence in front of us. We listened carefully and treated witnesses fairly and with respect, leaving the room feeling that their voice are being heard.

If confirmed for a second term, I hope to bring more discussions on smart growth, a balance between needs for housing and jobs, and the need to establish sustainability in Hawaii through the conservation and protection of our precious, but limited resources.

- Q6: What issues do you believe that the Commission has handled well in the past? What issues do you believe that the Commission should address in the future?
- A6: The Commission's staff has done a good job in communicating with the petitioners of our rules and policies to make our hearings more efficient. It avoids surprises and reduce controversies.

In light of the Bridge `Aina Le`a case, the Commission needs to take a look at its enforcement powers. We can set conditions but we don't have any power to follow through if the petitioner is not in compliance. Our only recourse is to revert the property to its original designation which is hard to enforce as you see what happened in the Bridge `Aina Le`a case.

The Commission should also look into how it can be part of the solution in our affordable housing and sustainability issues. Sea level rise is also something that the Commission should take a look at.

- Q7: During your service on the Commission, were there possible conflicts of interests involving you that arose? How were those potential conflicts addressed? If you were to continue to serve, can you foresee any other possible conflicts involving you?
- A7: None arose. Although before a hearing on Ho'Opili Development which I was the chair of the commission, I disclosed and ask for an opinion from the Deputy Attorney General regarding my previous employment with the Hawaii Regional Council of Carpenters. I was advised that there is no conflict based on previous court rulings. For the sake of transparency and before the hearing began, I asked all parties involved if there are any objections in my participation. All parties responded, no objections.

I don't see any future conflict. If a conflict does arise, I will disclose the conflict to the Chair of the Commission and ask for legal opinion.

Q8: Is there any other information regarding your experience and background that you believe should be considered for your nomination?

A8: I was fortunate to be on Senator Daniel Inouye's staff for 10 years. Every year, I had the privilege to accompany several of the Senator's staff on the Senate Appropriations Committee's subcommittee on Agriculture during their travel to Hawaii. We visited various agriculture and conservation areas on Oahu and the Neighbor Islands to assess the federal funding needs for the state. During those visits, several local farmers shared their stories, and I learned how many of them had succeeded with the help of federal funding. I also learned that despite these success stories, we still have a long way to go to achieve sustainability in our islands. Government funding is not the only answer. What is most needed is the overall framework of land management to preserve, protect, and encourage the best use of Hawaii's valuable land.
