I am in strong support of HB1172 due to the traumatic effect fireworks can have when they are unregulated and outside of scheduled, anticipated shows. Veterans with PTSD can easily be triggered by fireworks when they aren't expecting them. People have lost their animals due to fireworks going off and them running away. Fireworks should be regulated and only allowed on specific, set days and times.

I am writing in support of HB 1172.

We all know that there will probably never be a complete ban of fireworks on Oahu. The current restrictions of needing a permit to purchase firecrackers and the date/time restrictions of firecracker usage was a compromise that people learned to live with and planned around.

Sadly, the use of illegal aerials and legal fireworks being used illegally (outside the legal time frame), in addition to the house-shaking "bombs", have increased year after year. And the police are simply unable to enforce the current law because they are not a first-hand witness.

There are not many laws that can only be enforced unless seen directly by the police. Speeding. Running red lights. Illegal fireworks. All can be equally deadly.

I have friends who are animal care-givers. They rescue, foster, adopt, and love cats and dogs that are abandoned at the beach, tied up to fence posts, thrown out of moving cars, left in dumpsters. These people give their time, money, energy and heart to the animals. No matter how many animals you have it still breaks your heart when one dies. Especially if it is because of a senseless, illegal act.

Markie was rescued along with his female companion and their puppies; they had all been dumped at a graveyard in Pearl City right before a major storm. Once old enough, the puppies were quickly adopted. Markie was shy, but adorable and plans were being made to find him a loving home. A few days before New Year's Eve, one too many firecracker bombs went off. Terrified, Markie got into a fight with another, equally terrified, dog. Markie did not survive. We cannot and do not blame the other dog, it wasn't his fault. The unpredictability of the firecrackers, especially the bombs, terrifies and traumatizes the innocent animals that have no place to hide.

Knowing that there will be firecrackers at a specific time on a specific night is something that can be planned for; the animals can be sedated if necessary, they can be kenneled and sheltered. It is not the ideal situation, but it is livable and workable.

If we cannot ban firecrackers totally, at least give the police the tools they need that will help them enforce the current law. How many more innocent lives do we need to lose?

In strong support of HB 1172 HD 2 SD 1 - Relating to Fireworks

Aloha Chair Taniguchi and members of the Committee,

Poi Dogs & Popoki (PDP) is a nonprofit animal welfare organization with a mission to help people and their pets. We are in strong support of HB 1172 because we believe it will make property owners think twice about whether to allow illegal fireworks on their property or be held legally responsible for allowing the activity. The biggest problem with the current law is that we know WHERE the illegals are originating from, but do NOT know who is lighting the fuse. Therefore HPD does nothing.

Illegal fireworks – both aerials and other legal fireworks used illegally (prior to New Year's Eve) – start in Ewa Beach on Halloween. By Thanksgiving Day, it's a daily occurrence. And well in February, we still have illegals after football games and/or boxing or MMA fights. It is difficult for people to grasp the fear and stress that some animals experience due to fireworks. Unless you are seeing it first hand, you will fail to understand the chaos it causes in the lives of our animals and their owners.

For the past 3 years, I have called HPD repeatedly to report my neighbors who set off illegal aerials throughout the year. I even had video. And each time that they bothered to show up (which was a 50/50 chance), I got a different response from the officer but most often it had to do with the fact that THEY – the HPD – had to see firsthand the violation before they could make an arrest. And more recently, the only thing they would do was give a warning. They did NOT always show up. But I continued to take the video.

2016 was the worst...2017 not far behind. Bombs every night for 2 months. Day and night. 5 am. 5 pm. Midnight. It was painful and sad to see the animals (all rescues) – with fear in their eyes, panting out of control, and able to climb 6 foot fences just to run, to get away, to hide. Even with medication similar to Xanax, they had no relief. For three weekends leading up to New Years, I resorted to full-on sedation of the largest dogs. All of these "solutions" come with risks. And all of them cost money. I spent over \$500 just to treat the animals. And it still didn't help on most nights. On New Years Eve, I drove the circuit of Fort Weaver and Ewa Beach Roads (a loop) and saw at least 10 "parties" with people setting off illegal aerials in the middle of the road. I had to literally stop my vehicle and wait for them to finish lighting the fireworks. Any officer could have made an arrest that night. But none did. The fireworks went on till 4:30 am. They started again at 5:30 am and went all day.

In Ewa Beach, I had to put up with fireworks through the second week of January including the national football championship. And then again on Chinese New Year. And again on Superbowl Sunday. The last bomb went off at 8:30 pm. I could hear it discharge from its container – it was that close. And then the bomb – so loud it rattled the windows. And then my 100 pound mastiff scaled the 6 foot fence of his dog run, panting like it was 120 degrees.

When animals are scared, they are capable of anything. And sadly – this mastiff was so scared that 10 days before Christmas, after a series of bombs, he scaled the fence and killed one of my smaller dogs. Markie was in emergency care for 5 days before I had to euthanize him. It cost me \$12,000.

Today – we all have cell phones that take pictures and videos. In fact – you can find a video of Ewa Beach on New Year's Eve. We need HB 1172 because it at least provides HPD with the tools to make the arrest and hopefully – make a conviction. At a minimum – I understand that the bail is \$2,000 in Weed and Seed districts. We need relief.

And please – I am tired of the "its da cultcha" argument. My family has homestead in Papakolea so I know all about popping fireworks on New Year's Eve. But I am older. And wiser (I think). And a lot more compassionate about the people and animals around me. Fireworks are out of control. And while our legislative bodies lack the political will to ban all fireworks (both state and county), please at least give us (and HPD) the tools to fight fire with fire. And that is – if my neighbors decide to use illegal fireworks, then they need to pay the consequences. At this point in my life – I have nothing to loose. And nothing to fear. Except another horrible year of illegal fireworks.

Entertainment does NOT trump quality of life. Please pass HB 1172.

Dear Chair Taniguchi and the members of the Senate Judiciary Committee:

My name is Michael C. Findley. I am a resident of Makakilo, and I am submitting this testimony in support of HB1172 HD1 SD1. Fireworks present safety hazards to those untrained in their proper handling, as well as to those who may be in the vicinity of their use, either knowingly or not. Fireworks also can cause damage to personal property such as roofs and vehicles. Further, illegal fireworks represent a nuisance from loud noise, and litter from the residue of expended explosives becomes an unsightly mess that illegal fireworks users often leave for someone else to clean up so that the residue does not wash into our drainage system and potentially pollute our local ocean environment. Fireworks are best handled by professional pyrotechnicians to mitigate or eliminate all of these hazards and problems. Passing HB1172 HD2 SD1 will help to discourage unqualified persons from using fireworks illegally by making it easier to catch them in the act and document their violations of the law.

The problem of illegal fireworks is widespread, and the law as currently written does not enable law enforcement officers to respond effectively to the problem. This bill will help give law enforcement the tools they need to prosecute those breaking the law by allowing individuals to photograph or videotape any illegal activity as it pertains to illegal fireworks, and by allowing law enforcement to use these photographs or video as probable cause to make investigations and arrests. In essence, it allows neighborhoods to become more self-policing, which is necessary because the odds are very low that a police officer happens to be nearby to witness perpetrators setting off illegal fireworks. HB1172 also will hold property owners liable if they knowingly allow an individual to handle or use illegal fireworks on that owner's property. This will incentivize property owners to refuse to permit illegal firework activity on their property.

I respectfully request that you pass out HB1172 HD1 SD1 to help mitigate the illegal fireworks problem. Please pass this measure to empower private citizens to collect relevant evidence that can help our local law enforcement officers to discourage and reduce the use of illegal fireworks in our neighborhoods.

Imagine sitting in your garage, reading a book, smoking a cigar, enjoying the evening breeze and all of a sudden BOOM! Watching your favorite program on TV, or just an evening walk...BOOM...BOOM...BOOM. This all starts from the beginning of November through the week after New Years'. The problem is, you never know when it's going to happen.

For someone who serve two (2) tours in Vietnam and was deployed at the onset of Desert Storm, and another who was deployed to Iraq, and another who was deployed to Iraq and Kuwait, these unexpected bursts of one (1) second have a far lasting effect.

For my husband and sons, it causes anxiety and anger. With my husband, it often triggers sleepless nights, unwanted memories or nightmares of his time in Vietnam. Many of our veterans in Hawaii suffer from PTSD, and I'm sure they too have the same or similar experiences.

As a wife and mother, it upsets me to see to my husband and sons go through or deal with the aftermath. So much so, that I've looked out my upstairs window, wait until another BOMB goes off, identify the direction, if it is near my home, go to the location and ask the people at the residence to stop setting off illegal fireworks. So, I would not have a problem being a witness as this bill proposes.

Even when HPD is called, by the time they get to the site, the people stop and wait till they leave, then start again. Existing laws relating to the purchase and use of illegal fireworks is quite frankly and according to HPD officers not enforceable. So, what's the point of having laws that cannot be enforced?

While I believe stopping the influx of illegal fireworks should be done at point of entry, we often hear there's no money to support additional resources. So where do the fees collected for the fireworks permit go to? It was estimated that over \$240,000.00 was collected for this pass New Year. That sum could potentially be used to support at minimum four (4) positions to check the containers coming into our ports. Some may say that's not enough, but it is a start!

Or, perhaps we need to look at just allowing firecrackers for cultural practices and banning everything else except for controlled public dislay by the professionals.

Meanwhile, I strongly support this bill as a first step in addressing this problem and hope you will too. Mahalo for the opportunity to present my testimony.

This bill will help give law enforment the tools they need to prosecute those breaking the law by allowing individuals to videotape any illegal activity as it pertains to illegal fireworks and for law enforcement to utilize the video in making arrests. in essence, it allows neighbors "to police each other" particularly as police officers are never actually present when perpetrators are setting off illegal fireworks. This bill will also holdproperty owners liable if an individual is engaged in illegal fireworks on that owner's property.

I further would recommend that they not be allowed to be sold on island. They are "illegal" I believe that word should mean something.

WRITTEN TESTIMONY ONLY

Thank you for the opportunity to offer testimony in **support** for House Bill No. 1172, H.D. 2, S.D. 1. This draft of the bill will allow law enforcement officers to establish probable cause for fireworks offenses based on statements from witnesses, photographs, video, and other recordings authenticated by witnesses. This bill also provides a new liability provision for property owners who knowingly allow other individuals to detonate fireworks on their property.

I offer this testimony as a private citizen.

There have been many amendments to the Fireworks Control Law (FCL), Chapter 132D, Hawai'i Revised Statutes. However, individuals continue to irresponsibly detonate aerial devices and articles pyrotechnic in dense residential communities. Thus, the current FCL fails to provide law enforcement agencies with the ability to effectively enforce the provisions of the FCL.

The beginning of "fireworks season" fluctuates between Halloween and Thanksgiving Day, and continued for a week or two after New Year's Day in my Kapolei neighborhood in 2016-2017. In 2017-2018, the season started later in the year and finished earlier. At its worst, imagine loud, unanticipated explosions which shake the windows of a Mānoa Valley home every hour, for 3-4 hours, every single night for 30 or more days straight with the grand finale on New Year's Eve.

I served in our nation's armed forces in the United States Army Reserve and the Hawai'i Army National Guard for nearly a decade. I was deployed overseas and returned from Operation Iraqi Freedom 08-09 in September 2009, but I was not prepared for what awaited me later in the year. I write as a veteran, but not on behalf of other veterans because they have their own unique opinions and experiences.

In the beginning, the bright flashes of light and detonations were unexpected and I responded accordingly based on my training from the military. I distinctly remember leaving the Capitol late one evening because I was preparing for the Regular Session of 2010. I was driving on the H-1 freeway near the Middle Street split when I observed a bright flash of light, heard a loud explosion, and thought it was an Improvised Explosive Device (IED). It took me nearly a minute to calm

down and realize that I was at home in Hawai'i and safe. Thankfully, I have been able to adapt to and anticipate fireworks detonations over the past couple of years.

Unfortunately, there are many veterans afflicted with Post Traumatic Stress Disorder (PTSD), and they are unable to adapt to and anticipate fireworks detonations. Each veteran reacts to these detonations in their own way. Some veterans jump out of their living room chair, some say expletives, and others drop to the ground. An unexpected detonation startled me in December 2016 while I was watching television at home and made me jump out of my chair. However, it saddens me to observe this kind of reaction and more, tenfold, from my father nearly every single time an irresponsible individual detonates an aerial device in my Kapolei neighborhood.

Aerial devices have also been getting louder and stronger over the past couple of years. I am able to anticipate most aerial devices because the initial shot sounds like it originated from a mortar tube. The biggest difference is that aerial devices are louder and shake the house more often than not. Veterans, like my father, residing in dense residential communities should not have to cope with these <u>traumatic</u> experiences within the confines and safety of their own homes.

I respect that firecrackers and fireworks are a distinct part of culture in Hawai'i. Every friend I know from Hawai'i grew up with firecrackers, bottle rockets, jumping jacks, and watching uncle light an aerial device into the night sky. Families join together at homes, parks, and other locations to celebrate the approaching New Year. I am not opposed to aerial devices and articles pyrotechnic during Independence Day, New Year's Eve and Day, and Chinese New Year. However, multiple detonations, every evening, over the course of 30 days or more can no longer be tolerated in dense residential communities.

Furthermore, I have observed professional fireworks companies prepare professional fireworks shows which require approval from various local, state, and federal regulatory agencies. A 24 hour fire watch is also maintained once the fireworks arrive due to amount of explosive material being stored in a single area or vehicle because of the hazard it poses. While professional companies store their fireworks in bunkers, irresponsible property owners store vast amounts of fireworks in their homes which places them, their family, and their neighbors at risk.

I believe this draft of the bill will allow law enforcement agencies and their officers to effectively enforce the Fireworks Control Law, and I implore you to pass this bill, un-amended, with a recommendation for passage on Third Reading.
