Chair LoPresti and members of the Committee, I am Jonathan Johnson, Executive Director of the State Foundation on Culture and the Arts (SFCA), and I am grateful for the opportunity to testify in **SUPPORT** of H.B. 1223.

The National Endowment for the Arts (NEA) and the Department of Defense recognize the benefits of the arts and have a partnership, Creative Forces: NEA Military Healing Arts Network. This partnership serves the unique and special needs of military patients and veterans who have been diagnosed with traumatic brain injury and psychological health conditions, as well as their families and caregivers.

Healing arts use creativity through music, visual arts, dance, drama, creative writing, craft-making and other creative pursuits in both clinical and non-clinical settings to promote health and well-being and improve quality of life.

Participation in creative arts therapy or in community arts programs can help reduce stress, decrease anxiety, and increase positive emotions. Creative arts therapies increases patient engagement across all health interventions. Patients acknowledge improvement in sleep, memory, pain, cognitive function, and the ability to confront emotional challenges. Family members who engage in creative arts therapies express similar benefits as well. Creative arts therapies are non-invasive and cost-effective medical treatments.

Nationwide, more than five million military families provide care for a family member with Traumatic Brain Injury (TBI) or Post Traumatic Stress Disorder (PTSD). Only half of veterans who need PTSD treatment seek it. Community-based arts programs can serve as a de-stigmatized access point for those who wish to learn about creative arts therapy in the clinical setting. 1

With over 110,000 veterans, service members and their dependents in Hawaii, such programming would be appropriate. Through this initiative, organizations sponsoring programs in the arts, culture and humanities, could expand their focus to include the military.
