Dear Chair Luke and Members of the Committee,

I am writing in strong support of HB 1716. There are solid educational and public policy reasons to support the creation of a Youth Commission. It will provide a site in which specific dispositions can be cultivated, and a model at the state level that can be duplicated at the local and school levels, so that young people can develop critical dispositions necessary for effective civic engagement, through practice and modeling.

The first important disposition is a willingness to use political participation through legal channels to raise questions about social problems and to achieve justice. This kind of experience can illuminate the structures and purposes of different types of political practices, and help young people practice strategies for gathering information and evaluating that information using basic principles of statistical, historical, and public policy analysis.

Second, young people need to develop the disposition to engage in public reasoning in a spirit of mutual respect and willingness to listen. If political debates in bodies like a Youth Commission involve disagreements about how to interpret pertinent values, how much weight to give them, and how to institutionalize them, young people shoul be able to develop the critical skills that enable them to reflect rationally on political debate and simultaneously to connect with others empathetically.

A local youth commission would establish a structured and direct line of communications between our policymakers and our youth regarding key issues that impact our communities. HawaiiKidsCAN strongly encourages diverse and underrepresented voices to receive the earnest consideration they deserve in the pool of potential appointees. This representation is critical right now and for the future of our democracy, because it will immediately elevate the invaluable perspectives these youths can provide and create an ever-widening source of new role models and leaders across our communities.

Aloha! My name is Delia Ulima and I am a Statewide Initiative Manager for the HI H.O.P.E.S. Initiative. We are the local site for the national Jim Casey Youth Opportunities Initiative/Annie E. Casey Foundation and EPIC 'Ohana is the lead agency for this work in Hawai'i. The Initiative works with systems, such as the Department of Human Services-Child Welfare Services, Family Court and other service providers and partners within the public and private sector to create opportunities and support transitioning foster youth to successfully move into adulthood and become a contributing part of our community.

I would like to submit testimony in support of House Bill 1716, which establishes a youth advisory commission within the offices of youth services to advise the governor and legislature on issues relating to youth.

One of my primary roles with the HI H.O.P.E.S. Initiative at EPIC 'Ohana is to oversee the work of the HI H.O.P.E.S. youth leadership boards. These boards are made up of current and former foster youth between the ages of 14-26 and there are five boards; on O'ahu, Kaua'i, Maui and East and West Hawai'i. Their roles are to educate others about the needs and experiences of foster youth, advocate for policy and practice improvements, and collaborate with key stakeholders to create opportunities and supports for young people so they can thrive and become successful adults. These boards have been in existence since March 2010 and have made a tremendous impact on making positive changes within the child welfare system and collaborating with the community to improve outcomes for foster youth. Some of their legislative achievements include championing the efforts to extend voluntary care to age 21, Medicaid to 26 for former foster youth before the Affordable Care Act became law and a normalcy and prudent parenting law that encourages social development and protects caregivers, signed into law on June 29 of 2016. This year, they are championing a bill that provides foster youth in care with clear rights. Their voices are powerful and they are resilient, passionate individuals who have overcome enormous challenges and yet still choose to have hope and to serve their foster brothers and sisters. They are leaders and serve with purpose and vision. Many of them have gone on to college, graduate school, have families and are serving in various capacities throughout the community.

It is for this reason that I support the creation of a committee that will allow young people to have a voice and the ear of the governor and the legislature. When we listen to young people about what is important to them and about those things that impact their lives, we all win as a community. I give this support, however, with some well-intentioned recommendations. I think we, as adults, often want to include the youth voice and may create groups or committees thinking that it will yield the outcomes that we're hoping for, but that is not always the case. In my experience overseeing the work of several youth boards over the course

of the last several years, a strong and effective youth board/committee that practices authentic youth engagement will ideally have the following: structure, guidance, support, and opportunity. There has to be an adult leader/s to guide, mentor, support and train them. There needs to be youth-friendly and age-appropriate guidelines and expectations. There has to be training, support, preparation, compensation for their time and the opportunity to practice, present, participate, advocate and collaborate. It takes time, dedication, the right skill set and tools to encourage and develop youth engagement and leadership, the right people and a budget to adequately run youth boards or advisory councils in an efficient manner, in a way that is beneficial for the intended purpose and for the personal and professional development of the young person.

This is an amazing opportunity for young people and for the State. I support HB 1716 and am excited for the prospect of a youth advisory council for the State of Hawaii.
