OFFICE'S POSITION: OYS supports the intent of the measure but requests that any appropriation not affect the priorities in the Executive Biennium Budget. There are currently youth driven advisory boards or councils in the community that focus on areas pertinent to their specific interests, such as the HI HOPES Youth Advisory Council that aims to educate, advocate, and collaborate with the Department of Human Services, Child Welfare Services, to improve the child welfare system, including foster care. Another example is the Teen Link Hawaii Youth Advisors sponsored by the Coalition for a Drug-Free Hawaii that provides valuable input regarding youth perspectives on living a substance-free lifestyle. OYS believes the youth voice should be recognized and included in determining policies and recommendations on important matters impacting their lives. OYS has the following additional comments on coordinating and sustaining an effective youth advisory commission:

- Members should be diverse, including a strong representation of youth at risk.
- Adequate funding for coordinating, training and implementation is critical for success.
- Recognize youth have busy schedules, need flexible options for meetings, and should be compensated accordingly for their valuable participation.

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the families of ASHLEY GREY, DAISY KASITATI, JOEY O`MALLEY, JESSICA FORTSON AND ALL THE PEOPLE WHO HAVE DIED UNDER THE "CARE AND CUSTODY" OF THE STATE as well as the approximately 5,500 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that approximately 1,600 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

HB 1716 HD1 establishes a youth commission within the Office of Youth Services to advise the Governor and Legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets relating to youth and appropriates funds for this purpose.

This Commission is a great way to engage our children and youth in civic issues and to help them understand the broader reach of policymaking. The Commission would be strengthened by including youth (male and female) who have been houseless, youth who have been justice-involved and youth who have been in the foster care system. This would enhance the Commission's knowledge and thinking about better ways to assist our youth who are struggling with challenges in their lives.

We urge the committee to pass this bill and help our children and youth become active and engaged participants in civic issues. These are our future leaders and our greatest treasures! Mahlo for hearing this important bill. We urge the committee to pass it. Mahalo for this opportunity to testify.

Thank you for the opportunity to offer testimony in <u>support of HB 1716 HD1</u> which establishes a youth commission and appropriates funds in the Office of Youth Services to advice the Governor and the Legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets relating to youth.

The Hawai'i Public Health Institute (HIPHI) engages in a number of policy efforts to ensure that Hawai'l is the healthiest place to live. The Coalition for a Tobacco-Free Hawai'i (Coalition) is a program of HIPHI that is dedicated to reducing tobacco use through education, policy, and advocacy. With more than two decades of history in Hawai'i, the Coalition has led several campaigns on enacting smoke-free environments, including being the first state in the nation to prohibit the sale of tobacco and electronic smoking devices to purchasers under 21 years of age.

Part of the Coalition's success can be attributed to the work of our Youth Council. The Youth Council is a statewide network of youth and young adults representing all four Hawaii counties. In the last four years, they have championed campaigns to raise the age of sale of tobacco to 21, protect minors from secondhand smoke in cars, and now – to regulate vaping and keep tobacco stores away from schools.

We have engaged our youth as part of policy solutions, providing ways for them to lead and channel their motivation and experiences into effective community change. Through youth-led legislative campaigns, our youth leaders have been able to explore community challenges in public health and potential solutions. They learn how to develop a campaign and build a network to educate their peers and create policy change.

HB 1716 provides a critical opportunity for Hawai'i youth to become involved in the legislative process and gain recognition as an important voice for change. HIPHI is in support of this measure and we respectfully ask you to pass this measure out of committee.
