Chair Ing and Members of the Committee:

The Department of the Attorney General provides the following comments.

H.B. No. 1722 amends the Hawaiian Homes Commission Act (HHCA) to establish a cesspool compliance grant program and special fund for the purpose of assisting lessees of Hawaiian home lands with cesspool upgrade or conversion costs. The bill also establishes that recipients of a cesspool compliance grant are ineligible for the cesspool upgrade, conversion, or connection income tax credit under section 235-16.5, Hawaii Revised Statutes (HRS).

First, we note that pursuant to the procedures of the U.S. Department of the Interior (USDOI), any amendment to the HHCA triggers the USDOI's review to determine whether the proposed amendment requires approval of Congress. To avoid the time it can take to complete such a review, the Committee might consider that the intent of the bill can be realized without amending the HHCA; a cesspool compliance grant program and special fund for lessees of Hawaiian home lands can instead be statutorily established in the HRS.

Second, this bill uses several terms that should be defined for clarity. The terms in need of definitions can be found on page 1, lines 9-13, of the bill; they are "cesspool," "septic system," "aerobic treatment unit system," and "sewerage system." Sections 235-16.5 and 342D-72, HRS, both provide identical definitions of the terms "cesspool,"

"septic system," and "aerobic treatment unit system." Section 342D-1, HRS, defines the term "sewerage." We recommend that this bill include definitions similar, if not identical, to those found in sections 235-16.5, 342D-1, and 342D-72, HRS.

Third, the term "beneficiaries of this Act" is used on page 1, line 7, and page 2, line 4, of the bill to identify those certain individuals eligible to receive funds from the proposed cesspool compliance grant program. This term may be overbroad for the purpose of the bill because the term "beneficiaries of this Act" would include all native Hawaiians who meet the eligibility requirements of the HHCA, regardless of whether that individual holds a lease to Hawaiian home lands. To limit the eligibility for the proposed grant program to those beneficiaries who actually hold a lease, the term "lessees" should be used.

Finally, for uniformity with existing wording of the HHCA, the term "property" on page 2, line 5, of the bill should be replaced with the term "tract."

The Department defers to the Department of Health and the Department of Hawaiian Home Lands (DHHL) on the merits of H.B. 1722 and provides the following comments for your consideration. H.B. 1722 establishes a grant program to assist beneficiaries on Hawaiian home lands with the costs of upgrading or converting a cesspool. The measure also provides that a recipient of such a grant is ineligible for the cesspool upgrade, conversion, or connection income tax credit under Hawaii Revised Statutes (HRS) section 235-16.5. The measure is effective upon approval and applies to taxable yeas beginning after December 31, 2017 with funding for the program effective July 1, 2018.

The Department requests that DHHL be authorized to periodically provide to the Department a listing of any recipient of the grant along with their tax identification number so that the Department can ensure that such person does not also claim the tax credit under HRS section 235-16.5. In like manner, the Department requests authority so that it can communicate with DHHL whether an individual has claimed a tax credit under HRS section 235-16.5. Such information would otherwise be considered confidential taxpayer information, and disclosure of any such information is would be prohibited under HRS section 235-116.

- 1 **Fiscal Implications:** None for the Department of Health (Department). The measure establishes a
- 2 grant program and special fund to assist beneficiaries on Hawaiian Home Lands with cesspool

- 6 **Department Testimony:** We appreciate and support the intent of this initiative, but defer to the
- 7 Governor's Executive Supplemental Budget Request for the Department's appropriations and
- 8 personnel priorities. Cesspools are a major source of pollution to Hawaii's waters. There are
- 9 approximately 88,000 cesspools in the State, discharging approximately 53 million gallons of
- untreated sewage into the groundwater every day. Ground water flows into drinking water sources;
- since ninety-five percent of all drinking water in Hawaii comes from ground water sources, this
- 12 cesspool pollution can potentially harm human health. Groundwater also flows into streams and the
- ocean, harming public health and the environment, including beaches, recreational waters, and coral
- 14 reefs.
- During the most recent regular Legislative session, Act 125 was passed, requiring the replacement
- of all cesspools by 2050. The Legislature has taken important actions to address Hawaii's
- 17 cesspools. There is an urgent need to protect the public health and environment with cesspool
- upgrades as soon as feasible. These upgrades can be to sewer, septic systems or any other
- individual wastewater systems that comply with the Department's Chapter 11-62, Hawaii
- 20 Administrative Rules.
- 21 The cost of upgrades will be high, averaging \$20,000 to \$30,000. The Department is open to
- various forms and strategies of financial support for homeowners who upgrade. Expanded tax

- 1 credits and grants are two possible options that would help homeowners afford the phasing out of
- 2 cesspools.
- 3 This bill addresses a small part of the overall cesspools problem with Department of Hawaiian
- 4 Homelands properties, but is one step in the right direction.

Aloha Chair Ing, Vice-Chair DeCoite, and Committee Members:

I am submitting testimony on behalf of Hawaiian Community Assets (HCA), a Native Hawaiian controlled nonprofit HUD-approved housing counseling agency that specializes on serving the unique housing needs of native Hawaiian beneficiaries of the Hawaiian Home Lands Trust to **STRONGLY SUPPORT HB1722 with amendments**.

HB1722 would provide the opportunity for native Hawaiian beneficiaries to upgrade or convert their existing cesspools. In our work as a housing counseling agency, we have determined the need for amendments to this existing bill in order to ensure broader, more widespread upgrading or conversion of cesspools by beneficiary families statewide.

Amendment 1: Make the Tax Deduction a Non-Refundable Tax Credit

According to the Department of Housing and Urban Development's Housing Needs of Native Hawaiians Report¹ released in May 2017, Native Hawaiians overall report the highest levels of poverty and lowest median incomes of any other population in the State. As a result, through our counseling services, we have determined that the vast majority of native Hawaiian beneficiaries do not report tax liabilities on their tax returns. Therefore, a tax deduction would do little to assist beneficiaries in the upgrading or conversion of their cesspools. For this reason, we recommend an amendment that would convert the tax deduction to a non-refundable tax credit.

Amendment 2: Increase the Tax Credit Amount to \$25,000

Recently, HCA has been assisting native Hawaiian beneficiary families budget for upgrading or conversion of cesspools to septic tanks. With the majority of families considered low- and moderate-income, earning at or below 100% the Area Median Income, the average cost of upgrading or conversion of \$45,000 is extremely cost prohibitive. For this reason, we recommend an amendment to increase the tax credit amount from \$10,000 to \$25,000 to help make the upgrading or conversion more affordable for our beneficiary families.

Amendment 3: Extend the Term of the Grant to 5 Tax Years

Currently, the bill is in scheduled to be in effect for 1 tax year. This provides little time to build public awareness and to coordinate the resources necessary for beneficiaries to upgrade or convert their cesspools, including working with contractors and the various Counties and Department of Hawaiian Home Lands (DHHL) for permitting. We recommend to extend the term of the grant to 5 tax years, which would allow for organizations like HCA to work in a public-private partnership with the State to educate families and assist them in the process of upgrading and conversion as well as promote the tax credit and navigate the often complicated process of working with both the Counties and DHHL.

House Bill No. 1722 establishes a grant program to assist beneficiaries on Hawaiian home lands with cesspool upgrades or conversion costs; establishes that a recipient of a cesspool grant shall not be eligible for the cesspool upgrade, conversion, or connection income tax credit; establishes the Cesspool Compliance Grant Program Special Fund (CCGPSF); and appropriates \$50,000,000 in general funds for FY 19 for deposit into the CCGPSF.

While the Department of Budget and Finance takes no position on the establishment of a cesspool grant program for Hawaiian home lands beneficiaries, as a matter of general policy, the department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and

the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 1722, it is difficult to determine whether the proposed special fund would be self-sustaining.

In addition, appropriating \$50,000,000 in general funds for FY 19 for deposit into the CCGPSF may impact the Administration's ability to fund other programs and activities in the FY 19 Supplemental Budget.

We defer to the Department of Hawaiian Home Lands on the operational impacts of implementing a cesspool grant program.

The OCC Legislative Priorities Committee is in favor of House Bill No. 1752 and support its passage.

House Bill No. 1752, is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it aims to protect and restore marine protected areas with the most fish depletion.
